Where do I find my application status?

There are two places you can check the status of your application:

1. From your **Dashboard** when you log into TMT

What do I need to do to Submit my application?

Before you make payment and submit your application, you will need to be sure all application elements have been confirmed. You should confirm the Background Check element once you have downloaded the Fingerprint Background Check Supplement.pdf (for your records), and follow the instructions on the FBCInstructions.pdf to submit your fingerprint cards to the MT DOJ:

How do I know what I am missing so that I can make payment?
