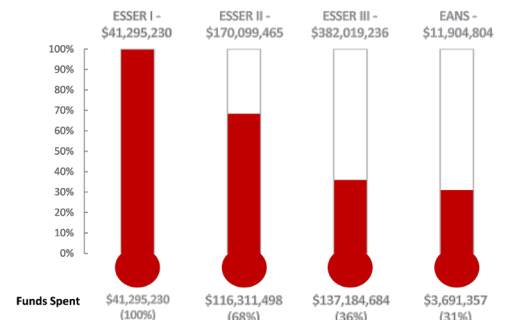

The **ESSER ARP III funding cycle** closes on September 30, 2024. **You have about 21 months to spend down this grant.** Cash Requests should be submitted no later than September 25, 2024. The Final Expenditure Report (FER) should be submitted no later than October 25, 2024.

January's **Virtual ESSER Guidance Sessions** will take place during the week of January 16-20.

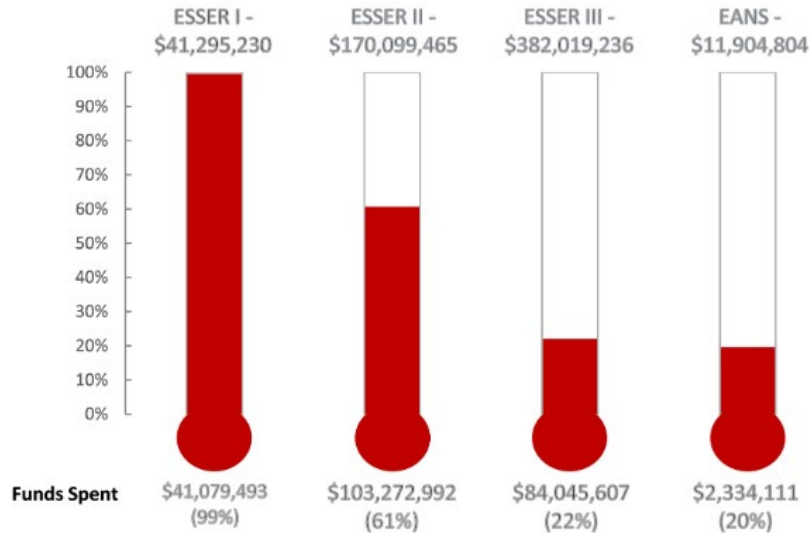


**Looking Back:**
