The CARES Act of 2020 states that there will be an equitable share set aside for all private/non-public schools that were in operation on or before March 13, 2020. Normally, county superintendents do their yearly update to the non-public schools in October. Would you be able to send out an email to your group letting know that the OPI needs them to update their list of non-publics in the OPI web app for private school participation? Here is the link:

CARES ACT Private School Equitable Share Update

The CARES Act of 2020 states that private/non-public schools may receive an equitable share of the funding to offset costs and other associated issues relating to educating their students during the COVID-19 pandemic. As under regular federal program law, private/non-public schools may receive equitable services based upon a proportional share of the funding, but direct cash payments to these entities are not allowed. Even though Montana districts recently completed their private/non-public school participation in federal programs questionnaires a month ago, Montana districts will be required to complete the process again asking these entities if they want to participate in equitable share services under the CARES Act of 2020. Please note that all CARES Act funds received by a district are subject to the equitable share provision.

The calculation for the proportional share for Cares Act funds is also different than Title I as it is the proportion of the enrollment at the private/non-public school divided by the total public and private/non-public enrollment in the district.

The OPI understands the burden this places upon the district in both time and fiscal resources. However, districts may not receive nor use CARES Act funds until the private/non-public school participation has been addressed. It is because of the OPI's intent to get CARES Act funding to districts as soon as possible that we are requiring the window be reopened as soon as possible. Even if the non-public has checked do not contact within the OPI web application, the district must contact the school with the CARES Act funding option.

Here are the directions to input data into the system:

- 1. Hover over the Data entry tab.
- 2. Click on the CARES Act Participation Data-District tab.
- 3. Update by selecting the private/home school from the dropdown menu.
- 4. Select CARES Act funding if the non-public school wants to participate.
- 5. If the non-public does not return the document, check NR-No Response
- 6. Hit the Save button.

Districts must follow the normal procedure for contacting private/non-public schools, which includes sending a certified letter informing non-public schools of their right to participate in the CARES Act funding. However, the OPI is shortening the window to respond to ten consecutive days. The district must also hold consultation with any entity that is interested in participation. Districts will enter the participating private/non-public schools within the OPI private school web application after the forms are returned. Districts will also have to enter the private/non-public schools and their enrollments in Egrants. The OPI recommends that districts use the following language in their notification to non-public schools:

Dear Private/Non-Public School Leader:

The CARES ACT of 2020 gives the state of Montana supplemental educational funds for all public schools. Part of these funds must be set aside for private/non-public schools to participate. These funds will be set aside as a proportional share of the CARES Act funds to provide equitable educational services to non-public school students. Please note that non-public schools may not receive direct cash payments from the district.

Due to these new funds, <DISTRICT NAME> is reopening the window to ask non-public schools if they want to participate in equitable share services under the CARES Act of 2020. Please return the enclosed document by <DATE>. You will have 10 days from the receipt of this notification to return it. If the form is not returned by the stated date, the district will mark your school as "Not Participating". If you have further questions, please contact <STATE DISTRICT CONTACT INFORMATION>.




Nutrition Update May 28, 2020

Many schools in Montana have quickly responded to the needs of their students and are currently providing meals through the available flexibilities for operation during unanticipated school closures and the removal of the congregate feeding requirement. Since March 16th, 151 SFA Sponsors have moved from operating the National School Lunch Program (NSLP) to operating the SFSP. Of these **151 (of 253) SFA Sponsors, 85 registered as new SFSP sponsors for Summer 2020**. On average, MT OPI adds 1-2 new sponsors each year.

Sure, I'd be happy to share.

We have been doing **curbside pickup and utilizing buses to deliver** into the community. Paraprofessionals and teacher volunteers ride these buses and it gives them a chance to connect with our students. We have **averaged about 1,000 meals per day** total and have delivered over 30,000 meals via buses. This has allowed us to keep both bus drivers and paras employed, we haven't laid off a single employee during this situation.

We also used our backpack meal program and food pantry to support families who had food insecurity and even some who were in quarantine. Our Community Welfare Specialist and Counselors primarily facilitated this. Once the federal regulations loosened up and allowed us to provide multiple meals on Fridays, the demand for this dropped significantly. Our community is certainly an example of where **loosening those regulations made a big impact**.

We have **several different scenarios we are planning for next year**, obviously none of us knows what September will bring. We will more than likely have most of our **younger students eating sack lunches in their classrooms** to avoid having large groups cycling through a common area and increasing exposure for students and staff. **Older kids** will likely use our available space and social distance, again likely utilizing **grab and go sack lunches** rather than buffet or service lines.

I can't stress how much the success of our program in these trying times is due to Ruth Pentecost and her crew. They have had a very positive "can do" attitude and I believe have used this challenge to improve their skills and flexibility. They have tried to be creative with what they offer, cater to students' preferences, and not just put out a reimbursable meal. Additionally, everything was served with a smile and warm greeting.
