Guidance on Mass Gatherings

CDC Considerations for postponing or cancelling a Mass Gathering.

- The overall number of attendees.
 - o Larger gatherings off more opportunities for person-to-person contact.
- The number of people attending who are at greater risk of more serious illness after contracting COVID-19.
 - Older adults and persons with severe pre-existing health conditions.
- The density of attendees within a confined area.
 - From what is currently known about the virus, spread from person-to-person happens most frequently among close contacts (within 6 feet).
- The potential economic impact to the participants, attendees, staff, and the larger community.
- The level of transmission in your local community and the level of transmission in the areas from which your attendees will travel.
 - Consult with local health department to better understand the level of transmission within your community.
- If there are ways in which to significantly reduce the number of attendees.

At a minimal-to-moderate level of community transmission, it is recommended to:

- Cancel gatherings of more than 10 people for organizations that serve higher-risk populations.
- Cancel community-wide mass gatherings (cutoff threshold is at discretion of community leadership)

At a substantial level of community transmission, it is recommended to cancel mass gatherings of any size.

Other considerations:

- Doing the event virtually
- Holding a separate memorial or honorary service at a later date
- While it is possible to have a funeral, they must, in the interim, be limited. Updated guidance released by the White House on March 16 suggests no public gatherings larger than 10 people for the next 15 days. Updated guidance from the CDC released on March

16 suggests no gatherings of more than 50 people for the next eight weeks. Information below offers suggestions for how you may handle services in the interim.

- Bodies can be transferred and embalmed using proper PPE.
- Decedents can be buried or cremated but state and local requirements may vary.
