## **CARES** Act

## **Coronavirus Aid, Relief, and Economic Security Act**

## \$2 Trillion Emergency Relief Package

Approved 96-0 in the Senate on March 25
The House will consider on Friday, March 27
*expecting a bipartisan voice vote to approve* President Trump expected to sign immediately



- **#** Extraordinary process
- **#** Relief package, not an education "stimulus package"
- **#** Additional bills may be forthcoming if/when costs rise, revenues decline
- **#** Preserves chiefs' authority over K-12 in federal law
- **#** K-12 set-aside = largest SEA-level discretionary formula program in history
- **#** Very flexible to respond to emerging needs

## **Emergency Supplemental Funding**

### Education Stabilization Fund: \$30.75 billion

- 1% (\$307 million) for grants to states with highest coronavirus burden
  - ED must release public notice inviting applications w/in 30 days

### • \$13.5 billion for elementary and secondary education formula grants

- .5% set-aside for outlying areas and .5% set-aside for BIE schools
- Federal state local by Title I formula (FY19) through SEAs
- 90% distributed to LEAs by Title I formula
- SEAs may reserve up to 10% (~\$1.35 billion) for grants and statewide emergency needs, including up to 0.5% for admin
- USED must issue notice inviting applications to SEAs within 30 days and approve SEA applications within 30 days

## LEA Uses of K-12 Formula Funds

**Substantial local authority and discretion:** 

- Any activities authorized under ESSA, IDEA, Perkins, Subtitle B of McKinney-Vento Homeless Assistance Act, Adult Education and Family Literacy Act
- Coordinate emergency response
- Support school leaders
- Ensure preparedness and coordination
- Purchase cleaning supplies
- Purchase education technology
- Mental health supports
- Summer learning
- Etc.

## **Additional Requirements**

**SEA** must provide assurance it will maintain support for elementary and secondary education and postsecondary education

Waivable by USED

SEAs and LEAs must "to the greatest extent practicable" continue to pay employees and contractors

**#** Equitable Participation of Non-Public Schools

Section 2018 Se

## **USED Waiver Authority for 2019-20 School Year**

### **#** Authorizes streamlined process for SEA waivers of:

- Assessments
- Certain accountability requirements
- Certain school improvement requirements
- ESEA report card requirements
- Periods to obligate federal funds

**#** Authorizes SEA, tribe, LEA waiver submissions of fiscal LEA issues:

- Schoolwide Program poverty threshold
- Maintenance of Effort
- Carryover limitations
- Title IV-A restrictions including limit on ed tech hardware and broadband supports
- Certain requirements under Title II-A for professional development

### **USED Report on Possible Additional Waivers**

- Secretary shall provide a report to Congress within 30 days with recommendations on additional waivers under:
  - IDEA
  - Rehabilitation Act
  - ESSA
  - Perkins

## **Additional Education and Education-Related Funding**

- \$3 billion for governors education fund
  - Broad discretionary fund for higher education and/or K-12 supports to LEAs that the SEA has deemed most significantly impacted by COVID-19
- \$14.25 billion for higher education
- \$3.5 billion for the Child Care Development Block Grant
  - To provide child care assistance to health care providers, first responders, sanitation workers, and other essential workers in the response to COVID-19
- \$75 million for Head Start
- \$8.8 billion for Child Nutrition programs
- \$15.5 billion SNAP (food assistance)
- \$100 million SERV

## **Emergency Supplemental Funding**

### **Key Education Funding Takeaways**

SEAs will play a major role in targeting emergency funds to highly impacted COVID-19 communities

States need to start thinking now about how to distribute these funds in a strategic, efficient, equitable way

**#** There will be strict oversight of the ways these funds are spent

CCSSO is developing resources to support states in making key spending decisions

## **Next Steps**

**#** Urge House of Representatives' speedy approval of CARES (Friday)

**#** Advocate with ED for efficient allocations – 60 days max

**#** Stand up SEA and LEA grants management systems

CCSSO will provide strategic and technical guidance and support

**#** Consider statewide activities strategies, state guidance to LEAs

**#** Develop approach for broadband and tech deployment if necessary

**#** "Keep your receipts" of costs, and track effects on state budgets

**#** Build momentum for additional federal action if/when necessary

Division Deadlines March 31, 2020

**Assessment:** At this time, the OPI is unaware of any additional reporting required from local education agencies (school districts); however, given this federal waiver process was simplified and expedited to support states, it is possible some statutory and regulatory requirements were not addressed fully in the OPI's submission. The OPI is still reviewing what additional laws or regulations might need to be waived and request these additional waivers through USED during this novel coronavirus.

#### Health Enhancement and Safety:

- HB 601: they must submit extension, change in scope, or final expenditure report. Request by 6-30-2020.
- E-Grants 21<sup>st</sup> CCLC Grantees: Continuation Applications. Due 5-1-2020: can extend to 6-1-2020.
- 21<sup>st</sup> CCLC Grantees: submit APR data on attendance. Due 6-22-2020.
- STOP Grant: Second Step reporting. Due 4-10-2020, and then due 7-10-2020.
- E-Grants 21<sup>st</sup> CCLC Grantees: E-Grant Amendments. Due 6-1-2020.

Accreditation: Will need corrective plans back by June 1,2020.

Title I-V: E-Grants amendments are due April 10, 2020 (this was a two-week extension)

School Finance: No current deadlines; working on School Election.

CTE: Perkins Intent to apply April 30, 2020.
