Award amount: \$3,499,952.18

Award period: Four year award- March 1, 2020 to February 28, 2024

Funding Priority: Infrastructure

3 Goals: Technology updates and data standardization, new data linkages, sustainability

Goal 1: Rebuild OPI's SLDS technology and standardize the data

Why:

- Technology is outdated, too costly to continue repairing what needs replacement
- Analytics capabilities currently limited due to age of technology
- Original design needs updating to meet current and emerging data needs of OPI and schools

Benefit to MT schools:

- Expanded options for parsing data- GEMS, mapping, visualizations, comparison
- Lays technological foundation for easier, faster, and more consistent processes for reporting

Goal 2: Establish new data linkages and build data use capacity

Department of Labor and Industry, Tribal colleges

Why:

- Additional variables for more robust longitudinal data analysis
- Minimize duplicative analysis across government agencies
- Equity in data

Benefit to MT schools:

- Wage and CTE data will provide additional measures of student success
- Linked regional wage, unemployment, and related data for student advising
- Equity in data, increased ability to understand variables for populations of interest

Goal 3: Sustainability

Why:

- Revisions to technology require new documentation, processes, and policy revisions
- Cross-training prevents loss of institutional knowledge with staff turnover
- Grant-funded work needs comprehensive systems in place because future funding is not guaranteed

Benefit to MT schools:

- Continuity in data access and support for data use
- Expanded resources for existing and new analytics tools and data sets
- Availability of more timely information, more options for data training and support

ESSA Tribal Liaison

The Tribal, Family and Community Liaison Purpose:

This position directs and leads collaboration and communication efforts between OPI and Montana tribes by empowering tribal leaders, communities, and families to develop local, tribal specific educational practices that improve school performance and student achievement. The Tribal, Family, and Community Liaison is also the lead person to assess and provide Indigenous perspective in OPI interagency communication efforts, policies, and planning. This position leads and directs the tribal, family and community engagement unit. They also lead coordination efforts and initiatives between the Indian Education for All (IEFA) and American Indian Student Achievement units, specifically with respect to strong IEFA implementation within Comprehensive Support and Improvement and Targeted Support and Improvement schools.

Donnie Wetzel, Jr Biography

Don Wetzel Jr. was hired by the MT Office of Public Instruction in 2010 where he has worked with Montana reservation schools on implementing youth leadership programs and incorporating tribal knowledge and solutions to school climate and student identity. For over 9 years, he served as the American Indian Youth Development Coordinator at OPI, a position that works on enriching youth and building bridges between two worlds. Don also worked for the Montana-Wyoming Tribal Leaders Council for 13 years on numerous State and Federal issues as well as directing a Suicide Prevention grant.

PHASE ONE RETURN TO WORK GUIDANCE

Phase One includes the Governor's lifting of the Stay at Home order. (Executive Orders 2-2020 and 3-2020) Essential services continue to be exempt. The reopening of Montana will occur in phases, beginning under this directive with Phase One. The duration of Phase One is unknown.

Personal Responsibility

- Continue to practice good hygiene

PEOPLE WHO FEEL SICK SHOULD STAY AT HOME

- Do not go to work.
- Contact and follow the advice of your medical provider.
- Follow local health department guidance on isolation and quarantine.

Employees showing symptoms of COVID-19 should not come to the office

REMOTE WORK

The OPI is continuing remote work for its employees.

- Employees who need to come to the office should notify their supervisor.
- Any employee who is in a <u>vulnerable population</u> is strongly encouraged to work remotely.
- Employees with impacted children from closed school buildings and/or vulnerable family members should continue remote work.
- o Please contact the <u>help desk</u> for assistance in making sure your remote work technology needs are being met.

WORKING FROM THE OFFICE

- Access to OPI buildings remains restricted to employees and essential service providers only
- Continue to coordinate work with your supervisor and ensure that social distancing occurs. Supervisors are encouraged to accommodate alternative work schedules and specific needs.
- Employees who work at the office **must**:
 - o maintain the six-feet social distancing requirement.
 - Limit in-person meetings to under 10 people provided six feet of social distancing can be maintained. Meeting participants are to disinfect tables after any meeting.
 - Wipe-down items touched in common areas. Common areas are kitchen/break rooms, copiers, and supply cabinets. Items includes faucet handles, doorknobs, refrigerators, handles, and anything else touched or handled.
 - Hand sanitizer and wipes will be provided for use near entry points, in restrooms, and common areas.

Non-essential travel bans are still in effect.
