CEP Identified Student Percentage (ISP) Correction & Reporting Form

Submission Deadline: April 15th

Do not complete if there are NO changes to the annual April 1st DCA CEP ISP snapshot proxy data shown on MAPS's 'Community Eligibility Provision' form (App menu). This information is used to compile the May 1st publication report of eligible/nearly eligible CEP schools for the upcoming SY and applies to the following circumstances:

- 1. Report corrections to the annual April 1st DCA CEP ISP snapshot proxy data in MAPS for schools having a free direct cert ISP of at least 15% or higher.
- 2. Private schools that do not report student data to AIM that have identified at least 15% of the enrolled students are directly certified as free eligible.

CEP ISP calculations are established using the total number of students identified as free directly certified and total students enrolled at each school site as of April 1st.

Identified Students are directly certified for Free school meals through confirmation of eligible program participant data without the need for a household application.

Directly Certified students included in the CEP ISP are eligible for 'Free' school meals based on participation data from eligible programs that have been confirmed in DCA or from the program source & includes: SNAP, TANF, FDPIR, Homeless/Runaway, Migrant, Foster Care, Head Start, Medicaid-Free and Extended Eligibility (Extended Elig applies to SNAP, TANF, FDPIR & Medicaid only).

Medicaid-Reduced students cannot be included in the ISP count for CEP eligibility, only Free sources. Proof of Medicaid eligibility must be confirmed through DCA and cannot be confirmed any other way.

To be eligible for CEP, participating schools must have identified at least 25% of the enrolled students are directly certified as free eligible. The 25% minimum ISP threshold to participate can be applied to an individual school, a group of schools, or district-wide. Individual schools with an ISP below 25% may still be eligible if grouping CEP eligibility and the sum of the grouped schools' ISP is at least 25%. CEP reimbursement applies a 1.6 multiplication factor to the ISP to determine the Free reimbursement rate.
