July updates from the Office of the Superintendent of Public Instruction:

<u>A+ Awards to OPI Staff:</u>

BJ Granberry is retiring after nearly 30 years of service to Montana. Thank you to BJ for making Montana proud! We also want to thank Michael Hall who has directed our gifted and talented programs and is retiring. Additionally, we want to recognize Susan Court and Eric Swenson for receiving awards this month. Susan was given the Honor Award from SHAPE Montana and Eric Swenson has been inducted into the BPA Hall of Fame.

The State Budget:

On July 25th, the Governor's Budget Director announced that all four levels of mandated funding reductions in SB 261 must be fully implemented. Preceding today's announcement, and in preparation for this possibility, the OPI has had ongoing communications with local districts and other education stakeholders regarding how the reductions would occur. An estimate of the impact on each district can be found on <u>the OPI's website</u>.

• The Federal Budget:

On July 20th, The U.S. House of Representatives Committee on Appropriations approved its <u>Fiscal Year 2018</u> <u>Labor-HHS-Education funding bill</u>. It is still early in the federal budgeting process and with a tight timeline before the end of the federal fiscal year at the end of September, a continuing resolution at current funding levels could occur.

• ESSA:

Thank you to everyone who contributed to the draft ESSA state plan! The draft is now available for public input before it is updated and sent to the Governor in mid-August. Please continue to send your input to: <u>ESSAinput@mt.gov</u>.

<u>August School Payments:</u>

The OPI will adjust the August payments to schools to reflect SB 261's triggered funding reductions and HB 647's Natural Resource Development payments elimination. On August 25th, the OPI will disburse \$60.8 million to schools.

The new OPI website will be live by the end of August. It is designed to be more user friendly and helpful for district leaders. If you have any feedback as you use the new website, please reach out to <u>Dylan Klapmeier</u>.

Meetings/Events:

o The Council of Chief State School Officers met in South Dakota from July 9-11.

o The Montana Board of Public Education met on July 13th. The minutes can be viewed here: <u>http://bpe.mt.gov/Home/Audio</u>.

o The Council of Chief State School Officers Federal Liaison Network met in Washington, D.C. from July 18th. The OPI staff were able to meet with Congressional education committee staff, Montana's Congressional delegation, and representatives from the U.S. Department of Education to discuss ESSA and push back on federal regulations that do not work for Montana's schools.

o The National Title I Conference convened from July 19-21. The OPI staff had a strong presence at this conference and Montana's own Assistant Superintendent for Education Services, BJ Granberry, received a national award for excellence in Title I service.

o On July 20th the Superintendent met with Montana's education advocacy groups to discuss the ESSA draft. Representatives from MQEC, OCHE, BPE, MEA-MFT, LFD, MTSBA, and MASBO attended.

Professional Development and ACT Panelist Recruitment

MontCAS professional development

The assessment division has been busy offerings for The Teacher Learning Hub. These courses will be launched this fall.

Test Coordinator Academy:

The goal of this course is to provide system test coordinators with training and support for successful management and test administration of the MontCAS summative assessments (Smarter Balanced, ACCESS for ELLs, CRT Science, ACT, and the Multi-State Alternate Assessment). The course will take place over the school year to support system test coordinators as the test window for each assessment approaches. This offering is especially relevant to new system test coordinators.

Interim Assessments:

This goal of this course is to provide training that will allow districts and schools to implement the Smarter Balanced Interim Assessments. The training includes an overview of interim assessments, test administration basics, scoring training, and using interim data to impact instruction.

Assessment and Data Professional Learning Community:

The assessment and data online professional learning community will take place the 3rdWednesday of every month during the school year, except for December. This PLC will focus on assessment data and its uses in Montana's public schools. Each month will focus on a different topic in a live webinar. There will be an activity to complete each month prior to the live webinar. Possible topics include: MontCAS data, uses of Smarter Balanced interim assessment data, the Smarter Balanced digital library/formative assessments, GEMS, alternate assessments, and others.

PAO Science Course

The goal of the PAO Science course is to help teachers gain deeper understanding and familiarity with the new Montana Science Standards through a backwards design process.

As teachers make the transition to instruction aligned to Montana's Science Standards, they may need support with what, and how to tackle these new standards. In this course, teachers uncover instructional shifts and key concepts in assessing the three dimensions of Montana's new Science Standards. Teachers will complete this course with a better understanding of the features of quality assessments and how to incorporate these fundamental aspects of assessment into instructional materials (e.g., considerations for rigor, alignment, bias, and accessibility). Teachers will apply their knowledge to developing meaningful and actionable resources which can be shared with colleagues freely across the state in the online repository. This course is important for science teachers who wish to engage in developing formative assessments for classroom use.

Webinars:

A series of live webinars are planned for each month during the school year. The main focus will be support for test coordinators and communication of timely tasks each month, accessibility and accommodations information for special education directors and special education teachers, and accessing data from statewide assessments.

Formative assessment resources for the new science standards

PAO workshop

On Wednesday, July 26 – Friday, July 28, 2017 the PAO workshop convened to review Montana teacher-developed formative assessments and strategies. These resources are intended to help teachers tackle the new science standards which were implemented on July 1, 2017. The result of this work will be to provide aligned, high-quality formative resources online for teachers across the state to access.

Montana ACT call for panelists

The Montana Office of Public Instruction (OPI) is in the process of recruiting panelists to participate in establishing statespecific performance levels for the ACT assessment administered to grade 11 students in mathematics and English language arts (ELA). Establishing categorical proficiency among Montana's students is imperative to meeting the federal statutory requirements for assessments used in the statewide accountability system and Peer Review as mandated by the U.S. Department of Education.

In order to meet these requirements, the OPI will convene a panel to review historical ACT performance data and consider possible cut scores for establishing three or more performance levels. The OPI will seek recommendations from a diverse representation of Montana stakeholders, including (but not limited to) school administrators, teachers, higher education officials, business leaders, and parents from across the state. This panel shall be comprised of approximately 8–12 panelists for mathematics and 8–12 panelists for ELA and will contribute to the adoption of performance level descriptors (PLDs) used for Montana's public reporting.

Career and Technical Education (CTE) prepares Montana K-12 students for a wide range of careers and postsecondary education programs. CTE courses are found in Montana's middle schools, high schools and career centers.

CTE courses provide students with life and employment skills to make them highly desirable employees in today's modern workforce. Skills learned in K-12 CTE courses prepare students to enter the workforce or to continue their education with a much higher degree of focus and direction for their career goals.

Montana has 473 approved CTE programs and 648 certified teachers in Agriculture, Business, Marketing, Family and Consumer Sciences, Industrial, Trades and Technology, and Health Science. More than 150 Montana high schools participate in the federal Carl D. Perkins and state CTE grant programs to support and improve their CTE programs.

In addition to skills learned in CTE courses, many Montana students gain additional technical and leadership skills through participation in a Career and Technical Student Organization (CTSO). The seven CTSOs with active Montana chapters are: FFA; Business Professionals of America (BPA); DECA, An Association of Marketing Students; Family, Career and Community Leaders of America (FCCLA); HOSA, Future Health Professionals; SkillsUSA; and Technology Student Association (TSA).

2018 Carl Perkins applications are Open

The 2017-2018 Federal Carl D. Perkins E-Grant application opened June 30 and is available for public high school districts to open and complete. The allocations loaded into the E-Grants system are FINAL numbers. This means you can create a new application for 2017-2018 and begin working on it. To access your Perkins application, please click <u>here</u> and sign into E-Grants.

According to the Carl D. Perkins Act of 2006, allocation calculations are based on current U.S. Census poverty and population counts. Local Distribution of Funds to Secondary Education Programs are distributed by formula based on school district Poverty counts (70%) and Population counts (30%). In addition, any unobligated or unspent Perkins monies from the prior year are redistributed by formula to all high schools. The distribution explanation can be found in Part C Section 131(1) and (2) on pages 130 and 131 of the Perkins Act of 2006, The Official Guide.

TE01 District Applications are due by August 1 or before your program starts. You can submit this application anytime during the year, but it MUST be approved BEFORE traffic education classes begin.

If you have instructors who renewed their educator license this year, they likely need to renew their approval to teach traffic education. If they haven't yet done so, please encourage your teachers to submit the required TE05 Teacher Application. If they do not yet have a Traffic Ed Endorsement, they may need to verify traffic education college credits earned toward their traffic education minor.

Traffic Education (TE) Reimbursement \$94.12 per TE student in 2017

Many thanks to the 133 school districts that taught traffic education to 9,190 students last school year and submitted their year-end reports on time. The 2017 Traffic Education reimbursements will be electronically deposited in district accounts managed by county treasurers in early August.

The OPI will distribute \$865,000 to school districts that offered state-approved Traffic Education programs during the 2016-2017 school year. District costs were partially offset by the state reimbursement of \$94.12 per student. This annual reimbursement is made possible by a percentage of driver license fees collected by the Department of Justice, Motor Vehicle Division.

Driver Education reimbursement fluctuates from year to year depending upon the number of driver license renewals and other dynamic variables. The amount of FY2017 reimbursement compared to previous years reflects the number students and driver license sales which is the source of funding for the state special revenue Traffic Education account.
