## **Assessment**

#### 2020-2021 MontCAS Enhancements

The OPI Assessment Unit has shared several enhancements to the state assessment portals and the MontCAS program. Enhancements included reduced test set up for interims, fewer steps for district staff to manage user accounts in the assessment portals, and earlier access to Smarter Balanced interim tests. The Assessment Unit also announced the plan for the release of the STCs Corner website to System Test Coordinators (STC) this fall.

## **English Learner Exit Criteria**

The OPI has received approval for Montana's new exit criteria for the English language proficiency (ELP) assessments. English learners must achieve an overall composite score of 4.7, rather than a 5.0, on the ELP assessment, ACCESS for ELLs 2.0 (or WIDA), to be considered proficient in English and to exit English learner status. Additionally, Montana defined proficiency as an achievement level "P2" on the alternate ELP assessment for English learners with the most significant cognitive disabilities.

**#1:** Remember, there are those **kinds of information you should enter all year long**, with no specific deadline. These are:

- 1. Behavior
- 2. Enrollment
- 3. EL Identification
- 4. Optional Assessment Information for Interims

**#2: First official "date" specific deadlines are October 9**<sup>th</sup> **and 19**<sup>th</sup>, which gives you a little time before your first submissions are due. BUT, it never hurts to be reminded, and here's the actual breakdown:

- 1. Beginning of Year Verification, Oct 9th
- 2. Fall EL Assessment Verification, October 19th

#### Comprehensive Support and Improvement (CSI) Update

During the 2020-2021 school year, the Title I School Support Unit will partner with CSI schools identified through a **regional support model** to:

- Support the Comprehensive Needs Assessment (Operational and Instructional Components) process
- Assist schools in developing a Continuous Improvement Plan (CIC) including specific strategies
  - o Building community capacity to support kindergarten transitions;
  - o Building school board efficiency through a school board coach;
  - o Providing wraparound services to students and their families (e.g., mental and physical health services, mentoring);
  - o Engaging students in school improvement through youth voice and advocacy work;
  - o Supporting culturally responsive practices, particularly for American Indian communities;
  - o Implementing systemic literacy and math improvements through specialized instructional personnel including a variety of educators, as well as library media and digital literacy an
  - Use of the Montana Early Warning System to identify students at risk of dropping out of school, apply targeted interventions based on student needs, and track interventions over time to determine if the interventions are working.
- Provide ongoing support in achieving the goals in the CIC
- Assist schools in developing processes and procedures
- Participate in school leadership team meetings and district leadership meetings
- Provide professional development or connects them to other resources
- Provide technical assistance in progress monitoring and collecting of data
- Assist districts in establishing an assessment plan
- Assist districts in creating calendars for testing, meetings, etc....

#### Youth Vaping and Covid-19

A recent <u>Stanford University study</u> found that among youth who were tested for Covid-19, those who had ever vaped were 5 times more likely to be diagnosed with the virus than those who had not, and those who had vaped and smoked in the last 30 days were 7 times more likely. #### Montana YRBS Update and New Reports

The biennial 2021 Montana Youth Risk Behavior Survey (YRBS) is being planned for the last week of February, or a timeframe that works for your district. #### School Nutrition Programs Waivers for the 2020-21 School Year

The OPI School Nutrition Programs will be using five national US Department of Agriculture waivers during the 2020-21 school year to give districts flexibility in providing meals to students. The waivers are effective for the entire school year through June 2021.

- 1. <u>Non-congregate Feeding waiver</u> allows districts to provide meals to students who are doing distance learning. Students do not need to eat their meals on the school campus.
- 2. <u>Meal Service Time Flexibility waiver</u> allows schools to establish meal service times that support streamlined access to nutritious meals. Students may be provided lunch, and at the same time, breakfast for the next morning.
- 3. <u>Parents and Guardians to Pick Up Meals for Children waiver</u> allows schools to distribute meals to parents or guardians to take home to their children. Children do not need to be present for the pick-up of meals, but schools need to have procedures for accurate meal counting per student.
- 4. <u>Meal Pattern Flexibility waiver</u> allows schools to request a change to the meal pattern for safety measures. Schools are encouraged to meet the nutrition standards to the greatest extent possible. The OPI will approve the use of this waiver on a case-by-case basis.
- 5. Offer versus Serve Flexibility waiver allows high schools to serve complete meals for delivery or pickup for students doing distance learning.

#### Minimizing COVID-19 Risk within Driver Education

District personnel are encouraged to consult with their local health department, union representatives, and school administration to determine best practices for resuming Driver Education for the 2020-2021 school year. Districts should include Traffic Education recommendations in district re-entry plans in combination with the following considerations.

- Employ a mix of delivery methods for traffic education that may include distance learning as well as face to face instruction. A model <u>Teen Driver Education Curriculum</u> is available on our website and is a great resource for Traffic Education teachers.
- The required minimum 25 student contact days may be taught through e-learning by an approved traffic education teacher.
- Virtual instruction practices should be carefully documented as districts will need to provide a narrative describing the accommodations made during this time.
- Teachers will want to carefully assess and document students' knowledge and skills when conducting e-learning assessment practices.
- Behind-the-wheel instruction, CDTP testing, and vision screening can only be conducted face to face. Districts should maintain the Governor's social distancing protocols as they plan to resume these components.

We understand that you are still fielding a lot of questions from families who are concerned about waiting lists for Driver Education classes due to spring closures.
