Montana Education Updates

2021 Legislative Priorities

- 1. BASE Aid plus inflation
- 2. Adding special education to BASE Aid plus inflation
- 3. Fund in-state residential treatment for at-risk students
- 4. Transfer the Broadband for Montana Schools program from the Department of Commerce to the Office of Public Instruction

In addition to the above priorities, the OPI has been working closely with the Education Interim Committee on language clean up bills. These priorities do not represent the full range of bills that the OPI may provide support or informational testimony for. The OPI recognizes that revenue will be tight this session and therefore the OPI's top priority is ensuring that existing funding promises to our K-12 public schools are fulfilled early in the session. Stars and Stripes Initiative

The OPI and American Legion of Montana are partnering on a <u>Stars and Stripes initiative</u> to donate American Flags for Montana classrooms. This coincides with our updates to Montana's social studies standards. We must all work together to have strong civics education programs in schools. One way to encourage this is by proudly displaying the stars and stripes in every classroom. State law <u>requires</u> Flags in every classroom but only if schools can afford them or have them donated. The cost of the Flags are \$10 and donors can choose which school that flag goes to. The Flags are classroom-sized 16"X24" and include the staff and wall mount bracket.

New Federal Digital Learning Guide

The U.S. Department of Education today released a new <u>Parent and Family Digital Learning Guide [Inks.gd]</u>, a resource to help parents and guardians understand how digital tools can provide tailored learning opportunities, engage students with course materials, encourage creative expression, and enrich the educational experience.

Missing Child Photo Repository

We want to remind you to upload student directory photos to the OPI for inclusion in the missing child photo repository. The repository provides law enforcement with immediate, 24/7, year-round access to a child's school photo should a child be reported missing.

It's important to note that parents <u>must opt-in</u> for their child's photograph to be included in the repository, and **must be provided the following information** when opting-in:

- Information about the electronic photograph repository: The repository is authorized by Montana Code Annotated (20-7-1317, MCA) and requires the Montana Office of Public Instruction (OPI) to create and maintain an electronic directory photograph repository of all Montana students for the exclusive purpose of locating missing schoolage children. The repository provides immediate and 24/7 year-round access to a child's school directory photograph to law enforcement should a child be reported missing. Annually, districts must provide parents and guardians notice of the repository and a form to opt-in their student(s).
- Who will have access to my child's photograph in the photo repository? Your child's photograph will only be used by law enforcement for the express purpose of locating your child should he/she be reported to law enforcement as missing. No other use by OPI or law enforcement is permitted. Access by OPI staff will be strictly limited and controlled to staff or contractors creating and maintaining the repository.
- How do I remove my child's photograph from the photograph repository? A parent can opt-out at any time. Contact your school/district to request your child's photograph be removed.

- **How long will my child's photograph be in the repository?** Photos will be updated annually; if the photo is not updated and the parent doesn't opt-out, the photos will be purged from the repository after two years.

By November 10 county superintendents must electronically receive all TR1's entered by the districts in the Pupil Transportation Program. Every Student Succeeds Act

Seeking Public Comment on Proposed ESSA Amendment

After reviewing Montana's Consolidated State Plan under the Every Student Succeeds Act (ESSA), the US Department of Education indicated that Montana must include an exit criterion for Comprehensive Support and Improvement (CSI) small schools, similar to the exit criteria that is outlined for regular CSI schools.

Purpose:

The purpose of the exit criteria is to ensure continued progress to improve student academic achievement and school success in CSI small schools identified through the annual meaningful determination process. [ESEA section 1111(d)(3)(A)(i)(I)].

Thus, the OPI is preparing to submit an amendment to the Montana ESSA plan and seeks public comment on the following proposed amendment:

Using the process for annual meaningful differentiation, the OPI will monitor the schools identified for small school comprehensive support. The OPI has identified two criteria for exiting small school comprehensive support.

The first criterion is to exit out of the lowest-performing 5 percent of Title I schools. This is the basic criteria necessary to exit small school comprehensive support. Title I schools that are no longer in the lowest-performing 5 percent and all high schools that have improved graduation rates to be at or above 67 percent will be eligible to exit small school comprehensive support.

Once schools have met the first criteria, they must meet the second criteria to demonstrate continuous improvement and not fall back into the lowest-performing five percent.

The second criterion is to meet the academic growth goals (ELA and Math) set in a school's Continuous School Improvement Plan (CSIP) for the year they are in small school support and improvement as well as the following year. Every district and school is required to submit a continuous improvement plan. The plan will be driven by a comprehensive needs assessment and the school's report card and growth goals that include the same growth percentages each year as the long-term and interim goals set by the state.

November 30, 2020 Final Draft prepared and submitted to the DOE

Egrant Consolidated Applications for SY20-21 must be submitted and approved no later than October 31, 2020. Districts that have not completed the process by this date will be locked out of Egrants, and they will not be able to drawdown funds. To gain permission to submit after this date, district board chairpersons will need to email a request to Sharyl Allen, Deputy Superintendent, at Sharyl.Allen@mt.gov. The request must contain an explanation of why the submission was late, and give a plan to prevent this from happening again. Districts missing this deadline are also at risk of more frequent federal monitoring.

Connecting Adults and Minors through Positive Parenting in Montana (CAMPP MT)

CAMPP MT (Connecting Adults and Minors through Positive Parenting) is a new program through MT Department of Corrections. It is an innovative approach to begin the process of reunification of incarcerated parents (within 5 years of possible discharge from prison) and their minor children in a safe and supervised environment while providing supports in the community for positive sustainable reunification. This program is intended to break the cycle of incarceration and build stable family relationships to prevent more victims of crime in Montana in the future.

2021 Youth Risk Behavior Survey – Registration Underway

Registration packets were mailed October 1 to district superintendents for the 2021 Youth Risk Behavior Survey (YRBS). The biennial survey will be conducted in late February 2021 and is administered by the OPI through a cooperative agreement with the U.S. Centers for Disease Control and Prevention (CDC). The YRBS is 30 years old and is the only school-based survey in which students self-report unintentional injuries and violence (including suicide ideation and mental health status), tobacco use (including electronic vapor products), alcohol and other drug use, sexual behaviors, nutrition and dietary behaviors, and physical inactivity. Registration is open through November 30, 2020.

Upstart Update

Waterford UPSTART is a no-cost, at-home Kindergarten Readiness software offered the year before a child enters kindergarten. This Kindergarten Readiness software gives an exciting start in reading, math, and science (with a focus on reading). Currently, Montana has 206 families registered for UPSTART for the 2020/2021 school year! Of these families: 123 have completed the training, 100 have completed WACS (pre and post-test), and 93 families have begun using the program.

Summer Food Service Program Operations and Other Flexibilities Through SY 2020-21

On October 9th, the USDA extended multiple <u>nationwide waivers and flexibilities</u>. These extensions mean that districts operating USDA Child Nutrition Programs may have options for feeding students through June 30, 2021.

- Districts may continue to operate the National School Lunch Program (NSLP) or switch
 to the Summer Food Service Program (SFSP) through June 30, 2021. Please note that
 each program has different regulations and meal counting/claiming requirements.
 Districts must have an approved MAPS agreement with OPI School Nutrition Programs
 to operate and claim meals for either program.
- Here is a helpful resource on Meal Program Options

- Districts that have already been approved to operate the School Year SFSP may log into MAPS and extend their days/months of operation on the site applications through the end of the school year (or longer if planning to operate next summer).
- Districts that have not yet signed up to operate the School Year SFSP, but want to make
 the change must first complete the <u>School Year SFSP Form</u>. Once this form is submitted,
 you will receive a call from your <u>regional specialist</u> to determine next steps.

State Personnel Development Grant Awarded to the OPI

Montana OPI is a recipient of the new State Personnel Development Grant (SPDG), titled "The Montana Tiered System of Supports: Systematic Problem-Solving Approach to Implement Evidence-Based Practices with Autonomy". The purpose of this new grant is to improve and expand our professional development and coaching support focused on data-analytic problem-solving at the systems level. The project is guided by current research for professional development, which entails a state, regional, and district approach to build capacity. Training in districts will begin in fall 2021 and will be piloted in one region, with expansion to other regions in subsequent years.

In the meantime, training content on MTSS and related topics can be accessed on the <u>Teacher Learning Hub</u>. We will continue to add courses to the Hub to support MTSS implementation. Please check your <u>Regional CSPD</u> website as well, as they periodically offer professional development opportunities that support MTSS. Montana Autism Education Project (MAEP)

The OPI Montana Autism Education Project has some scholarships available for educators to attend virtual Picture Exchange Communication System (PECS) Level 1 or Social Thinking trainings. This intensive 13-hour interactive workshop is designed to teach educational and caregiver teams the theory and protocol for the Picture Exchange Communication System® (PECS®), an evidence-based practice based on Applied Behavior Analysis, typical language development, and B.F. Skinner's Verbal Behavior. Using presenter demonstrations, role-play opportunities, and video examples participants will gain a thorough understanding and handson experience of each of the six phases of PECS.

Updated Special Education Guidance and Resources

The special education unit has been working diligently to get updated guidance and resources specific to COVID-19 posted on the Re-Opening Montana Schools 2020 COVID-19 Special Education Information webpage. Notification to NAEP 2021 Schools

The participation requirement to administer NAEP in mathematics and reading in Grades 4 and 8 is required under the Every Student Succeeds Act for any district receiving Title I funding. Montana schools selected to participate in the 2021 administration of the National Assessment of Educational Progress (NAEP) have been notified. The assessment will take place between January 25 and March 19, 2021.

Fall Senior Testing with ACT

Remember to return test booklets, used answer documents and test administration forms as soon as possible after testing. Materials must be received by ACT no later than October 27 for the October 20 test date, or they will not be scored.

For seniors unable to test on October 6 or October 20, the Office of Commissioner of Higher Education (OCHE) and OPI are in conversations with the test delivery contractor (ACT) to see if additional dates can be added in the spring should enough seniors benefit from this possibility. Until we are able to determine if this flexibility is possible for Montana students, students eligible for the ACT's free fee waivers can test on the national test date, December 12, 2020 (Saturday). Updates on this option will be published in the OPI's Published Test Window Calendar and the "Staying Informed" resources described below.

No assessment can fulfill multiple and diverse purposes well so a coherent, system of assessments (balanced) is important. The guidance webpage includes a comprehensive overview of all things interims and includes an 18-min Quick Start Video. This guidance reinforces the Restart & Recovery: Assessment Considerations for Fall 2020 from the Council of Chief State School Officers (CCSSO).

The OPI is in the process of crafting "Montana COVID-19 State Standardized Testing Guidance." In the meantime, schools are encouraged to reach out to the OPI to share questions, concerns, and any challenges happening at the local level so the OPI Assessment Unit can support schools with these testing requirements. The State CTE/VoEd funding final allocations include funds for student enrollment within CTE program area courses and funds for having an active Career & Technical Student Organization. Please note, due to federal reporting guidelines, program enrollment and CTSO chapter membership numbers are not listed in the posted report. If you want the numbers, please contact your CTE program area specialist.

The CTE tab in TEAMS was made available last April and districts were asked to complete a few additional items on the tab and review the details carefully to make sure the data was accurate.

The 2020-2021 State CTE/VoEd Funding allocations will be distributed to districts by November 1.

HiSET Exam at Home

- Monitored by a human proctor online through ProctorU
- Available 2:00 5:00 pm MST, seven days a week

<u>HiSET state testing requirements</u> must be met to qualify for the HiSET Exam at Home. Individuals who are 16-18 years of age must apply and be approved by the OPI to take the test.

If not licensed by this date, the educator is considered nonlicensed and their FTE is not eligible for Quality Educator Payment.
