Chapters 55 and 57 Review

Deputy Superintendent Sharyl Allen and the Board of Public Education are reviewing ARM Chapters 10.55 (accreditation) and 10.57 (licensure). We must continue working to provide our school leaders and educators with flexibility.



Federal Waivers

- Summer Food Service Program: extended to June 30, 2021
- Report Card: still required for available data points
- Assessment: ED has not made a decision on spring standardized assessments. The OPI is pursuing a waiver or determining how local interim data could be used instead
- The OPI continues to advocate an extension of the CRF deadline while encouraging the Governor to allocate additional funds to education

Stars and Stripes Initiative

The OPI and American Legion of Montana are partnering on a Stars and Stripes initiative to donate American Flags for Montana classrooms. The cost of the Flags is \$10 and donors can choose which school that flag goes to. The Flags are classroom-sized 16"x24" and include the staff and wall mount bracket.

Promoting Career and Technical Education

The OPI continues to partner with businesses and industries to promote career and technical education. For the legislative session, we have March 26th scheduled for a Montana Ready Rotunda Day. Tribal Caucus Update

The 2019 Montana Legislature passed Senate Bill 40 (sponsored by Senator Frank Smith, 66th Session) requiring the OPI to create and maintain an electronic directory photograph repository of all Montana public school students for the exclusive purpose of locating missing school-age children. As of March 2020, the repository went into production and schools began uploading photographs. And, as of January 14, 2021, there are 23,288 (25,333 as of 1-27-2021 – or 17%) about photographs of students, or about 16.5% of the total public student population.

Accreditation/Educator Preparation Program

Variations to Standards Applications Due: Monday, March 1, 2021

The Board of Public Education's Administrative Rules of Montana (ARM) 10.55.604 "[Variations to Standards](#)," allows accredited schools to implement a variance to a standard or standards designed to meet or exceed results under established standards. Districts interested in seeking an initial or renewing an existing variance to a standard must apply to the Office of Public Instruction by Monday, March 1, 2021. An approved application will take effect at the beginning of the 2021 academic year.

The ARM 10.55.604 requires local trustees to provide evidence of the community's public participation and evidence of official board action approving the variance to standards application before submission to the Variations to Standards Review Board. American Indian Student Achievement

Language & Immersion Grants awarded to 2 districts & American Indian Graduation Boost Grants Awarded to 6 districts

The American Indian Student Achievement Unit awarded 8 grants to districts across Montana that serve American Indian students. Two grants are aimed at strengthening language and cultural immersion practices within public schools and six grants are aimed at increasing graduation rates across the state. The Indian Language Immersion Program (MCA: 20-7-1404) was awarded to Browning Public Schools and Crow Agency Public Schools. To qualify for this award, districts must have language classrooms that are instructing at least 50% of core content in their native language. Through the School Improvement Grant, a graduation rate Boost grant was awarded to Lodge Grass Public Schools, Rocky Boy Public Schools, Browning Public Schools, Brockton Public Schools, Wolf Point Public Schools, and Lame Deer Public Schools. These districts will work as a cohort to collectively increase their graduation rates and build capacity within their districts at sustaining long term graduation rates.

Educator Licensure

New Document Upload Feature

The Montana OPI has installed a new Upload feature to our Montana Educator Information System (MSEIS). This feature applies to new applications and to existing applications. Watch a brief instructional video at this link: [MSEIS Upload Feature](#)

Educators are now required to upload supplemental documents to their online application. This eliminates the need for applicants to either US mail or email any supplemental document into the OPI to complete a license application. All licensure applications require one or more supplemental documents to complete the application.

There are 3 Applications that cannot yet be submitted online through MSEIS:

- Adding an Endorsement to your current license
- Reinstatement of a Lapsed License
- Upgrading (e.g., Class 2 to Class 1 or Class 5 Provisional to a full license)

For all three instances, applicants will need to continue to mail the application and



supplemental documents to the Office of Public Instruction.

Changes to the ESSA Accountability System through an Addendum to the 2019-2020 Waivers and a limited Waiver for Targeted Support and Improvement Identification

The COVID-19 Addendum is important as it seeks to provide school districts with an extension of the COVID-19 Accountability waivers and relief from the impact of COVID-19 on the accountability system for the 2020-2021 school year. Given that Montana cannot adequately calculate an academic growth measurement, defined by comparing two consecutive years of a student's normalized assessment scores, or some of the measures of Montana's fifth flexible indicator for School Quality and Student Success (SQSS), it cannot meet the requirement to differentiate all public schools based on all five required indicators. Thus, Montana is proposing to shift the identification process forward one year to 2022-2023.

Because the waiver addendum does not apply to the annual requirement to identify Targeted Support and Improvement (TSI) schools, which are schools with one or more consistently underperforming subgroups for three consecutive years, Montana is also seeking a specific TSI waiver. Montana has sought these changes to provide relief and support to schools as a result of the ongoing COVID-19 pandemic. Montana will continue to advocate for school communities and students. These proposed changes do not preclude Montana from submitting amendments or additional waivers to gain greater flexibility in the future. Please note that the Montana OPI is currently applying to the USED for an assessment waiver for 2020-2021 statewide testing.

Through the Addendum and the TSI Waiver, Montana proposes to address the following components of the accountability system:

- Shifts forward timelines by one year to 2022-2023 for identifying CSI and ATSI schools because the growth indicator and the Student Quality or Student Success (SQSS) indicator cannot be calculated in 2020-2021.



- Shift exit criteria for CSI and ATSI schools to be in 2022-2023 based on data from the 2021-2022 school year.
- Shifts forward timelines by one year for measuring long-term goals and measurements of interim progress.
- Waive annual requirement to identify TSI schools in 2020-2021 for consistently underperforming subgroups.

On February 1, 2021, the final draft will be submitted to the U.S. Department of Education. Prior to submitting this COVID-19 State Plan Addendum template to the Department, the Montana OPI consulted with the Governor, afforded a reasonable opportunity for public comment, and considered such comments consistent with the consolidated assurances under ESEA section 8304.

New Kognito Simulations on the Teacher Learning Hub

The OPI Teacher Learning Hub is pleased to announce the addition of two new evidence-based Kognito Simulations for K-12 educators. These interactive mental health simulations use role-play with emotionally responsive virtual students to help educators learn about mental health, trauma-informed practices, and suicide prevention which supports improved student wellness and school safety.

Resilient Together: Coping with Loss at School (1 CEU)

A death in the school community can have profound impacts on the social and emotional health of students and staff. In this course, educators will learn the key elements of a crisis response plan and best practices for communicating with community members emotionally impacted by the event, and, if needed, connecting them to support. Participants practice these skills in role-play conversations with fully animated and interactive students and teachers. The content includes postvention information for when the death in the school community was by suicide. This course compliments the content of [Dealing with Grief and Loss in Adolescents](#) and multiple suicide prevention courses on the Hub.



Trauma-Informed Practices (2 CEU)

This course will help educators discover how a trauma-informed approach can improve their students' self-esteem, confidence, resilience, and achievement. In this simulation, participants will assume the role of a virtual educator to learn more about trauma-informed practices and student behavior while participating in interactive conversations with virtual K-12 students. This course complements the Hub Course *Overcoming ACEs in MT Schools: Childhood Trauma and Its Impact on Learning*.

NEW Medical Exemption Policy for COVID Reasons

The OPI continues to explore options for schools to ensure safe participation in state assessments this spring. Because of variable local conditions, intermittent school closures, and student absences due to COVID-19, the OPI will allow medical exemptions for COVID-related reasons for the 2020-2021 school year. The "Statewide Assessment Participation and Registration Guide" on the [Student Eligibility and Participation Page](#) was updated in late January 2021 to include guidance on how districts and schools can report these COVID reasons to the OPI for the non-participation data collection (see the [MontCAS Application Collection Schedule](#) for more details).

Adult Education: HiSET at Home Testing Option

The [HiSET at Home Option](#) is now available to minors in Montana. In order for 16 and 17 year old HiSET test takers to partake in the remote proctored option, they must complete either the [16 Year Old Waiver](#) or the [17-18 Year Old Waiver](#) to HiSET test. The waivers forms have been updated to include an area where test takers must acknowledge the HiSET at Home Option is recorded. After the waiver is completed, the test taker submits the application for the state for approval and then the state “unblocks” the account which allows the test taker to register for the test.
