Updates in Montana Education

School Safety

- Montana’s application for a federal STOP School Violence and Prevention Act grant through the U.S. Department of Justice was successful. It is a 3-year, \$500,000 grant with a 25% state match. The grant focuses on professional development for creating positive school climates and preventing school violence. The OPI will hire one federal FTE to assist in the creation of Teacher Learning Hub courses, to provide in-person professional development at education conferences, and to implement “Second Step” social-emotional learning programs in schools. The University of Montana Safe Schools Center is written into the grant as a partner.
- Montana DID NOT receive the *Grants to States for School Emergency Management Programs* from the Department of Education for assisting in school emergency management planning.
- Legislative School Safety Summit: The OPI will host a school safety summit on January 7th in the Capitol to showcase for legislators safety initiatives taking place in schools.

Federal/ESSA Update

ESSA Report Card

The OPI is seeking feedback on the DRAFT elementary and high school federal report card prototypes under ESSA. The DRAFT elementary report card can be viewed at this [link](#) and the DRAFT high school report card at this [link](#). Feedback can be emailed to ESSAInput@mt.gov. Some guiding questions are below. As you look at the report card, think of it through the lens of various audiences (parents, teachers, community members, administrators, etc.) and various purposes (transparency, school improvement, storytelling, etc.)

- **What other information would you like to see displayed on the report card?**
- **Are the report card tables and graphs easily understandable?**
- **How can the report card better guide and reflect student growth?**

The school report cards will be released displaying 2016-2017 school year data and current ESSA designations by December 31st, 2018, with the report cards displaying 2017-2018 school year data and the new ESSA designations being released in March of 2019. Then, each February/March the report cards will be released notifying schools, families and communities of the school's performance and ESSA designation. The schools will have the opportunity to review the report card before the public release. Schools will be given a template to design a cover letter highlighting data they are proud of, an area the school will be working on with a call to action to the community, and a local data point that they want to share that is not included in the ESSA report card.

Federal Education Funding

President Trump signed into law a funding bill that provides Fiscal Year 2019 federal funding for the Department of Education, and that keeps the rest of the federal government open through December 7, 2018. This appropriations bill provides the DoE with nearly \$71.5 billion in FY19, a \$581 million increase over current year spending. Most key education programs received funding increases. Montana's allocations will be known in the spring.

- Title I is increased by \$100 million
- Impact Aid is increased by \$100 million
- 21st Century Community Learning Centers receive a bump of \$10 million
- Title IV-Part A funding for Student Support and Academic Enrichment Grants receives an additional \$70 million
- Charter school grants are increased by \$40 million
- IDEA grants to states received an \$87 million increase
- Career and Technical Education is increased by \$70 million
- This bill also provides a \$200 million increase for Head Start and Early Head Start and a \$50 million increase for the Child Care Development Block Grant Program under the U.S. Department of Health and Human Services
- The U.S. Department of Labor receives \$15 million more for apprenticeship grants

Reminder: December 1, 2018, is the date that all licensed educators and professional staff must have registered his or her license with the OPI. Application Due Date for Variances to Standards- March 4, 2019

The Board of Public Education rule, “Variances to Standards” (ARM 10.55.604), allows accredited schools to implement a variance to standards designed to meet or exceed results under established standards. Districts interested in seeking a variance to a standard, which will be implemented in September 2019, must submit a [Variance to Standards Application](#) by March 4, 2019.

The variance to standards rule requires local boards of trustees to produce evidence of local public participation and evidence that the trustees officially approved the variance to standards application before submission to the Variances to Standards Review Board. Internships

November 15, 2018 is the date that post-secondary institutions must register internships with the OPI. If the internship is not registered, the new endorsement area will not be reflected on the educator’s license, and this could result in an accreditation deviation. Five workshops over four days are led by College Board-endorsed consultants that provide some of the best professional development available for AP[®] teachers and facilitators. Survey: Economic Impact of Emergency Response Rulemaking

The purpose of this survey is to determine the perceived economic impact to district budgets that may be realized through the proposed rule amendment and new rule of the Administrative Rules of Montana (ARM) 10.55 Standards of Accreditation. School district administrators, county superintendents, school board trustees, school clerks/business officials, PK-12 teachers, and special education service providers are asked to complete the *Economic Impact Survey Questionnaire*. Community partners, tribal officials, law enforcement, and disaster and emergency personnel are encouraged to respond as appropriate to districts. The survey can be found on the OPI's [website](#).

Fall 2018 CTE Data Collections Begin

The Fall 2018 CTE Data Collection begins on October 1 and ends December 31, 2018. The Fall CTE Data Collection is a follow up to last year's Spring CTE Data Collection. Students identified as CTE Concentrators last year (2017-2018) and graduated in the spring of 2018 should be contacted between October 1 and December 31 and asked their current post-graduation status. After contact, the appropriate post-graduation status code must be entered into the AIM/Infinite Campus data system for each CTE Concentrator. All high schools that received funding from the Carl D. Perkins federal grant program in 2017-2018 are required to complete this fall follow up collection to maintain their eligibility to receive Perkins funding. **Instructions for completing the Fall CTE Data Collection are on OPI's CTE [website](#).**

PLEASE NOTE: Be sure to verify the list of CTE Concentrators from what your district submitted last spring. Any additions, corrections, or changes to the list of CTE Concentrators must be made no later than **November 15, 2018**, to be accurately reflected in federal reporting and used to compute Perkins Performance Indicators for your school.

School Finance

Reporting American Indian Students

Students identified as American Indian in the AIM system at the time the data is imported into the MAEFAIRS fall count will generate funding for the Student Achievement Gap (SAG) payment in the ensuing year.

School district business managers/clerks should verify that the Students Imported From AIM In SAG Report located in the MAEFAIRS application accurately reports the number of American Indian students enrolled in the district. Changes to the FY 2018 Trustees Financial Summary

If you find a material coding error on your FY 2018 Trustees Financial Summary (TFS), you may submit a revision to Keri Ludwig in the School Finance Division. As provided in 10.10.504(6), Administrative Rules of Montana, material revision to the FY 2018 Trustees Financial Summary submitted by December 10 shall be accepted, limited to the following types of adjustments:

- Coding revisions between revenue and expenditure line items provided no change occurs in the fund balance of the budgeted funds.
- Revisions in the balance sheet accounts provided no change occurs in the fund balance of the budgeted funds.

Revisions should be submitted to Keri Ludwig by following these procedures:

1. Photocopy the original page of the Trustees Financial summary
2. Strike out amounts to be revised, including subtotals and totals
3. Hand write in the revised amount above or beside it, including subtotals and totals
4. Sign and Date pages to be revised
5. Scan and send as an email to Keri Ludwig, (406) 444-0783 (preferred method) to Fax to Keri Ludwig at 406-444-0509

When sending balance sheet account revisions, please also send any expenditure and revenue line item changes that correlate with such changes. The fund balance on the balance sheet should equal the ending fund balance shown on the statement of revenues, expenditures and changes in fund balance report after the revisions are made.

Changes that affect fund balance in a budgeted fund or immaterial line item coding changes must be reported as prior period adjustments in the trustees' financial summary for the current year, FY 2019. The district may need to adopt a budget amendment in the current year to record the prior period adjustment within the budget of a fund.

Salary and Compensation Expenditure Reporting

MAEFAIRS is currently available for the salary and compensation expenditure reporting. The Salary and Compensation Expenditure Report requires that all employees who received a paycheck during 2017-18 fiscal year be entered in the district's 2017-18 TOE data. For many districts, the 2017-18 TOE did not include employees hired after the TEAMS application was closed. The missing employees can be entered in the compensation expenditure TOE screen in TEAMS. The Compensation Expenditure Report is due **December 10th, 2018**.

District Classification

County Superintendents should verify/enter district classification data for all districts in their county in the County application. District classification data is used to determine which districts are required to report campaign finance activities to the Commissioner of Political Practices. Districts should verify their board composition with their county superintendent to assist with this collection. A report will be published to the OPI Elections Webpage prior to the opening of trustee candidate filing for the May 2019 elections. Important Security Changes to OPI Systems Coming

The OPI is making security changes to all systems you use to report and manage information submitted to the OPI. This change is happening so we can strengthen how we protect and secure the data you provide us.

Here's what you can expect as a result of these security changes:

1. Passwords will need to meet these criteria:
 - a. At least 12 characters long
 - b. Contain 3 out of the 4 of these: an upper-case letter, a lower-case letter, a number, and a special character (~!@#\$()%^&*) or a space
2. Systems you access will now also include language on the login page that notifies you of the following:

"This system is the property of the Office of Public Instruction. Unauthorized use is a violation of Montana Code Annotated § 45-6-311. Any and all uses of this system and all files on this system may be intercepted, monitored, recorded, copied, audited, inspected, and disclosed to authorized personnel. By using this system, the user consents to such. Unauthorized or improper use of this system may result in civil and

criminal penalties. By using this system, you indicate your awareness of and consent to these terms and conditions of use. Do not log in if you do not agree to the conditions stated in this warning.

You can expect to start seeing these changes this month.
