Instructions For Entering Student Attendance Agreements And Other Important Information

Tuition Timeline

- 1. Discretionary Open Enrollment Tuition.
- 2. Mandatory Tuition any time.
- 3. Collect Student Attendance Agreements (SAA) using the appropriate form.
 - FP14.1 Parent-Guardian/District/Parent Group Home Placement
 - FP14.2 Foster Placement/Group Home Placement by the court or a state agency
 - FP14A us for Option A, B, C or Programs Exceeding Average Costs
- 4. Send approved SAA's to OPI
- Students must have a State ID and an Enrollment in Infinite Campus.
 Enter residency information Infinite Campus. See AIM website. AIM Resources>Data Collection Information>Infinite Campus User Guides>District Residency. Other helpful resources ArcGIS to help determine what school district the student resides.
- 6. Enter the information to MAEFAIRS
 - Enter Indivudually
- 7. Review all entries in MAEFAIRS using the reports and views that are available.
- 8. Submit on or before June 30.
- 9. Send out statements to the District of Residence by July 15.
- 10. The first payment for the District of Residence to make to the District of Attendance is December after the year of attendance.
- 11. The last payment for the District of Residence to make to the District of Attendance is June of the following year.

Types of Placements and FP14 form to use

Parent-Guardian – FP14.1 – parent or guardian want their child to attend a school of choice

District to District - FP14.1 – if one district does not offer a program students can be placed in another district that does offer the program. Example a school on the east side of Billings Elementary district does not offer a Kindergarten program, these students can attend a program on the west side of Billings Elementary district. The students must have an SAA in place.

Foster Home – FP14.2 is State or Agency placement. Student in foster care outside of their resident district.



Group Home – FP14.1 if parent placement or FP14.2 if State or Agency placement. Student is placed in a group home outside their resident district.

State ID – the state ID assigned to a student in Infinite Campus.

Last Name – last name of the student.

First Name - first name of the student.

Birthdate – birthdate of the student.

Grade – current grade level of the student based on the current enrollment in Infinite Campus.

District of Residence – the name of the school where the student would regularly attend based on the physical address of the custodial parent. Where does the student sleep at night?

Date Attendance begins - when did the student start school at the district of choice.

Instructional Days In The School Year - how many days will the district of choice be offering classes.

Days enrolled – How many days was the student enrolled at the district of attendance? Do not subtract days absent.



Student Placement – who is requesting the placement. Placement can be requested by Parent/Guardian, District, Foster Home, or Group Home.

Individual Making Request - If the placement is Foster or Group Home, select the entity that is making the request, Parent/Guardian, State Agency, or Court Ordered.

Regular Ed Rate – will populate after the Student Placement has been selected. The dollar amount that populates is the lowest dollar amount based on the lowest percentage calculated between the district of residence and the district of choice.

The following fields are only used for students who require additional funding for Special Education purposes.

Special Ed Option – if you have a student who qualifies for this, you must select Option A, B, or C. Used for students that have a documented IEP. An Option C rate must be approved by the OPI before it is used.

Special Ed Rate – is the rate calculated using an FP14A. This rate is entered in this field.

Student With Needs – No IEP – this is selected if you have a student that does not have an IEP but would qualify for additional funding. If this box is selected, the Programs Exceeding Average Cost is available to enter a value. The amount entered comes from information on the FP14A. The amount can't exceed \$2,500.00

No Transportation Provided – is automatically selected. Transportation is the responsibility of the parent/guardian of an out-of-district student. Transportation can be provided but this is a decision made between the district of attendance and the district of residence. If the district is providing transportation, unselect the option.

Average Transportation Cost – this populates with the Average Transportation Cost calculated from the district of residence.

Additional Bus Miles for Non-Residential Students – add the additional bus miles for the student that is being provided transportation.

Over Schedule Bus Service Charge – the transportation costs that are agreed upon by the district of residence and the district of attendance. The amount entered can be up to the average transportation cost. It can be less but never more than this amount.

Comments - used for informational purposes.

Filter fields used to look for students who have been entered.

- 1. Select the Fiscal Year.
- 2. Select the LE this is always the District of Choice. This field will always populate with the district that is entering the information. The only time districts will have multiple choices is if you have more than one school.
- 3. From Infinite Campus copy the student State ID number. Or if you have the information enter the State ID by hand keying the ID in the field.

Paste the State ID number into the State ID: field in MAEFAIRS.

Or type in the students State ID number. Press the tab key or select the blue save button.

The student Last Name, First Name, Birth Date, and Grade will populate based on the State ID entered.



- 4. Select the District of Residence.
- 5. From the calendar select the Date Attendance Begins the first day the student attends the district of choice.
- 6. Enter the number of instructional days for the school year.
- 7. Enter the total number of days the student was enrolled. Start with entering the total number of instructional days. If the district of residence changes this will be modified when a new record is entered for a new district of residence.

If the student changes district of residence, enter the total number of days enrolled at the first district of residence. A new record for new for the student must be entered for the new district of residence.

8. Select the type of placement. It can be Parent/Guardian Placement, District to District, Foster Home Placement, or Group Home Placement.

Once the type of placement is selected, the tuition amount will populate in the Reg Ed Rate field. The amount that shows up is the lowest percentage rate calculated between the district of attendance and the district of residence.

9. Select save. The record will populate in the table that appears at the bottom of the screen.

10. Other Information

• Inputted Transportation Rate: Not required unless the district of choice and district of residence agree to provide transportation. Very limited and most likely will never be used.



- Inputted Regular Tuition Rate: The lowest rate calculated between the 2 districts. See the pdf provided by OPI on website.
- Inputted Special Ed Rate and Inputted Prg Exc Avg Cost. This rate is one or the other. A student can't have both.

How the Total Tuition is Calculated

Total Annual Tuition is the calculation of Inputted Transportation Rate + Inputted Regular Tuition Rate + Inputted Special Ed Rate or Inputted Prg Exc Avg Cost = Total Annual Tuition. This is the amount the district of residence will pay the district of attendance if the student stays for the entire year.

If the student was enrolled for the entire school year the total tuition amount will equal the Inputted Regular Tuition Rate.

If the student was enrolled for less than the entire school year the tuition will be prorated.

Example:

I have students James Bond and Harry Potter. James Bond never changed the district of residence. The student tuition is based on 1 enrollment at 1 district of residence for a total of 153 days.

The second student, Harry Potter was enrolled an entire year at the district of choice but moved to another district of residence after 23 days. Harry Potter started in Melstone HS school district, later moved to Shepherd School District and continued his enrollment at Huntly Project K12 Schools.

A new record is entered for Harry Potter that will reflect the number of days the student lived in the new district of residence. Both records will have the tuition prorated.



The calculation:

The district of choice is Huntley Project for both students. The district of residence is Billings HS for James Bond with a total of 153 days. District of Residence for Harry Potter is Melstone HS for 23 days and Shepherd HS for the remaining 130 days.

James Bond enrollment:

The tuition used is calculated between Huntley Project and Billings HS. Huntley Project has the lowest percentage with the lowest tuition rate calculated at 1,173.92. The calculation is as follows:

The daily rate is 1173.92/153 = 7.67 (7.6726) per day.

7.67 * 153 = 1173.92 (1173.9199) which is the Regular Tuition amount that Billings HS will pay Huntley Project.

Harry Potter enrollment:

The tuition used is calculated between Huntley Project and Melstone for 23 days. And Huntley Project and Shepherd HS for 130 days.

Huntley Project and Melstone with Melstone having the lowest percentage with the lowest tuition rate calculated at 555.48. The calculation is as follows:

The daily rate is 558.48/153 = 3.63 (3.6305) per day.

3.63 * 23 = 83.50 (83.5035) which is the Regular Tuition amount that Melstone will pay Huntley Project.

The tuition amount for the second district of residence for Harry Potter is calculated between Huntley Project and Shepherd HS. Huntley Project has the lowest percentage with the lowest tuition rate calculated at 1,173.92. The calculation is as follows:

The daily rate is 1173.92/153 = 7.67 (7.6726) per day.

7.67 * 130 = 997.45 (997.4483) which is the Regular Tuition amount that Shepherd HS will pay Huntley Project.



District, Foster Home, or Group Home Placement

For a District Placement, Foster Home Placement, or a Group Home Placement follow the same steps as you would for the Parental/Guardian Placement except when selecting the Student Placement, select the appropriate placement from the drop down, District Foster Home or Group Home Placement.

The next selections are an **OR** option. The student can have a special education option rate **OR** the student qualifies as a student with needs but does not have an IEP. If the student has a special Ed Option Rate select from the drop-down menu. The option can be Option A, Option B, or Option C. Then enter the appropriate amount. If the student has an Option C rate, this rate must be approved by the Office of Public Instruction before an amount is entered.

Option A and Option B are calculated by the district of attendance and agreed upon by both the district of attendance and the district of residence. Use the FP14A form to calculate these expenses.

Option C rates are calculated and approved by the OPI. This rate is used for a self-contained program provided by the district of attendance. The program has its own budget and serves a certain number of students. Only choose this option if you have an approved rate from OPI.

Students with needs and does not have an IEP can't have an amount greater than \$2,500.00. Use the FP14A to help determine these costs.

If the student qualifies for Programs Exceeding Average costs, fill in Section IV of the FP14A. This type of student does not have a formal IEP but has needs that cost above the normal allowable special



education program costs. These costs can't exceed \$2,500. The district of residence will pay the tuition and additional costs. The district of residence will use the tuition levy to levy the funds to cover the costs.

Tuition Views

This view is used for the District of Residence to get a list of students who attend out-side the district. This view provides the student information, the district of choice information, and the estimated costs they can expect to pay to the district of attendance in the following year. This is a valuable tool for the district of residence to help set the tuition levy amount.

The report is available for the District of Residence and is found in the View selection of MAEFAIRS.





The district of residence – Shepherd will run this report from the VIEW selection in MAEFAIRS. Shepherd should expect to get an invoice for tuition from Huntley Project by July 15 for the ESTIMATED amount of \$997.45.
