



TUITION RATES SCHOOL YEAR 2023-2024

Discretionary/Mandatory Parent and District to District Agreements

The maximum tuition rates for discretionary/mandatory parent agreements and district to district agreements (FP-14.1 at 20% of the Maximum Tuition Per-ANB Amount) for attendance during SY 2023-2024 are:

- \$ **637.54** for half-time kindergartners (KH) and Pre-K (PK) students with an IEP
- \$ **1,275.08** for full-time kindergartners (KF) and students in grades 1-8
- \$ **1,618.48** for grades 7-8 if the school runs an accredited 7-8 program or junior high
- \$ **1,618.48** for grades 9-12

Foster and Group Home Placements

The maximum tuition rates for foster and group home placements (FP-14.1 and FP-14.2 at 40% of the Maximum Tuition Per-ANB Amount) for attendance during SY 2023-2024 are:

- \$ **1,275.08** for half-time kindergartners (KH) and Pre-K (PK) students with an IEP
- \$ **2,550.16** for full-time kindergartners (KF) and students in grades 1-8
- \$ **3,236.96** for grades 7-8 if the school runs an accredited 7-8 program or junior high
- \$ **3,236.96** for grades 9-12

Amounts used for Calculations

The FY2024 Tuition Per-ANB Amounts (maximum per-ANB rate *plus* Data for Achievement, Indian Education for All, and the per ANB amounts of the Instructional and Related Services block grants) are:

- \$ **3,187.71** for half-time kindergartners (KH) and Pre-K (PK) students with an IEP
- \$ **6,375.41** for full-time kindergartners (KF) and students in grades 1-8
- \$ **8,092.41** for grades 7-8 if the school runs an accredited 7-8 program or junior high
- \$ **8,092.41** for grades 9-12

The FY2024 Maximum per-ANB rates are:

- \$ **3,061.50** for half-time kindergartners (KH) and Pre-K (PK) students with an IEP
- \$ **6,123.00** for full-time kindergartners (KF) and students in grades 1-8
- \$ **7,840.00** for grades 7-8 if the school runs an accredited 7-8 program or junior high
- \$ **7,840.00** for grades 9-12

The Tuition Per-ANB Amounts for FY2024 include:

- Data for Achievement Rate per ANB: \$ **22.89**
- Indian Education for All per ANB: \$ **23.91**
- Instructional Block Grant Rate per ANB: \$ **154.21**
- Related Services Block Grant Rate per ANB: \$ **51.40**
