After completing a redesign of the event, this year's New CTE Professionals Workshop focuses on early-career professionals—specifically Career & Technical Education professionals within the first five (5) years in a Montana Career & Technical Education classroom. Additionally, Montana CTE professionals who have participated in the past are invited to attend to enhance their classroom skills and knowledge of Career & Technical Education.

This **FREE** professional development opportunity will provide teachers who are new to the classroom, as well as those with five (5) years or less of experience, with information on a variety of roundtable and breakout sessions essential for success in the career and technical education classroom including



- --Perkins funding,
- --State CTE funding,
- --Advisory boards,
- --Professional development organizations,
- --Instructional strategies for the CTE classroom,
- --Work-Based Learning
- --CTE and program-area standards and guidelines, and

The workshop will be held at the Billings Hotel and Convention Center (1223 Mullowney Lane) from 8:30 am to 4:15 pm. The training is free of charge and lunch will be provided for attendees. Up to six (6) OPI Renewal Units will be offered. Attendees are responsible for their own travel and substitutes.

Fall 2018 CTE Data Collection BEGINS

The Fall 2018 CTE Data Collection begins on October 1 and ends December 31, 2018. The Fall CTE Data Collection is a follow up to last year's Spring CTE Data Collection. Students identified as CTE Concentrators last year (2017-2018) and graduated in the spring of 2018 should be contacted between October 1 and December 31 and asked their current post-graduation status. After contact, the appropriate post-graduation status code must be entered into the AIM/Infinite Campus data system for each CTE Concentrator. All high schools that received funding from the Carl D. Perkins federal grant program in 2017-2018 are required to complete this fall follow up collection to maintain their eligibility to receive Perkins funding.

Instructions for completing the Fall CTE Data Collection--called the 'Quick Reference Guide' for the Fall CTE Data Collection--are located in two places on the OPI website: on the AIM web page under the AIM User Guides button and also on the CTE web page under the 'Data Collections' button.



<u>PLEASE NOTE:</u> Be sure to verify the list of CTE Concentrators from what your district submitted last spring. Any additions, corrections, or changes to the list of CTE Concentrators must be made no later than **November 15, 2018**, to be accurately reflected in federal reporting and used to compute Perkins Performance Indicators for your school.

Please verify your Data in TEAMS - November 1 Deadline

Schools are currently entering data into OPI's TEAMS System (Terms of Employment, Accreditation, and Master Schedule). Data from TEAMS pertaining to Career and Technical Education courses, student enrollments, and teacher certification is used for Carl Perkins accountability reporting and factors that determine the State CTE (State VoEd) allocations. Additionally, beginning with the 2018-2019 school year, the data will be used to verify and approve Montana Career Pathways.

Therefore, it is imperative that the information submitted is complete and accurate. Any high school district planning to apply for Carl Perkins and/or State CTE (State VoEd) funding for next year (2019-2020) should submit the additional data in TEAMS for all current CTE programs at their high school.

When reviewing the data for your courses within the TEAMS System, please verify the following information is correct—

- --Name of teacher(s) for courses
- --All current courses being taught for the 2018-2019 school year are listed and the correct course title is listed under for the District Course Title
- --All courses listed are aligned to the correct Course Code & Title
- --Number of students enrolled and breakdown of males and females
- --Term Type for courses (Semester, Full Year, Quarter, etc.)
- --Class Minutes (the minutes of instruction for each individual course per the term type)
- --If an extended contract is identified along with the number of days of the contract

All data should be reviewed, verified, and corrected by November 1. After this date, TEAMS will close for new data entries.

The Montana FFA Association recently completed its annual District Leadership Schools (DLS). These schools are held in each of the state's eight FFA districts and help educate students about student-based projects, degrees,

awards and the opportunities that abound in today's FFA. Throughout the two-week program, state officers met with over 1025 students. District leadership schools were offered in Culbertson, Ekalaka, Colstrip, Absarokee, Livingston, Missoula, Fairfield and Malta. Additionally, the district's Ag Teachers receive updates from foundation and association staff.

The National FFA Convention will be held in Indianapolis beginning October 24th and concluding October 27th. Montana will have twenty-one different teams competing for national titles during the four-day convention. Also, thirty-five Montana members will be awarded the American FFA Degree which is the highest degree that can be bestowed upon an individual. This degree is based on the development of an outstanding student-based project as well as their involvement during their five years of FFA membership. What promises to be one of the highlights of the convention is a concert by Garth Brooks. Approximately, sixty-five thousand FFA members from across the U.S. will attend the annual convention.

Montana FFA welcomes ten new Ag teachers into the profession and would like to recognize the following four schools for starting brand new programs: Hot Springs, Glendive, Dodson and Broadview. There are currently two schools still looking for an Agriculture Education Instructor – they are St. Regis and Harlem. Good luck to these new teachers and programs!

Updated Framework for Business Education in Montana & OPI TEAMS K-12 Course Codes and Descriptions Reference Manual for Business & Marketing **Education Available**

The Framework for Business Education in Montana has been updated for the 2018-2019 school year. Within the Framework, updates have been made to the competitive event crosswalks for Business Professionals of America and DECA. The updated crosswalks reflect updates and changes to the competitive event programs at the national level effective for the 2018-2019 school year.

The Framework for Business Education in Montana provides teachers with common quidance for curriculum development and course content development. Review and update work for the Framework for Business Education in Montana was by a committee Montana business education professionals representing all classifications of Montana High School as well as business education teacher program coordinators from the University of Montana and University of Montana Western and the State Directors for Business Professionals of America, Montana Association and Montana DECA.

The course information within the Framework is organized by Career Clusters with the Common Career Technical Core as the standards for each cluster. Additionally, course content is aligned to the National Standards for Business Education and is crosswalked to the National Standards for Business Education and to the competitive event programs for Business Professionals of America and DECA.

While on the Business Education section of the Montana OPI website, be sure to download the Montana Business Education 2018-2019 Planning Calendar.

Also updated for the 2018-2019 school year is the OPI TEAMS Current Listing of All Montana K-12 Course Codes and Descriptions Reference Manual for Business & Marketing Education. The Montana K-12 Course Codes and Descriptions are used for the reporting of course taught in all schools and at all grade levels via the OPI TEAMS school staffing system. Updates to this year's manual include the removal of duplicated courses to help streamline course identification and the removal of "other" courses and codes. Additionally, the manual includes a complete listing of Montana teacher licensure course codes.

Within TEAMS, all courses taught are identified and aligned to a national SCED Code



with the local school course title listed as well as term type, enrollment numbers, and length of instruction. For Montana's Career & Technical Education programs, the TEAMS data is also used to generate the Montana CTE Student Participation Reports which are used to determine State CTE/VoEd funding allocations.

To assist teachers and administrators with mapping district courses to the OPI/SCED codes before the data is entered into TEAMS, a <u>TEAMS Participation Report Worksheet for Course Codes</u> worksheet is also available on the <u>Business Education section</u> of the Montana OPI website.

In May U.S. Secretary of Education Betsy DeVos announced the 54th class of U.S. Presidential Scholars, recognizing 161 high school seniors for their accomplishments in academics, the arts and career and technical education fields.

"I want to congratulate this year's class of Presidential Scholars on their achievement and also thank their parents, teachers and other academic advisors who have helped guide them along the way," said U.S. Secretary of Education Betsy DeVos. "These





students have pushed themselves to be the best they can be, and I am certain that devotion will serve them well as they continue their individual learning journeys."

The <u>White House Commission on Presidential Scholars</u> selects scholars annually based on their academic success, artistic excellence, essays, school evaluations and transcripts, as well as evidence of community service, leadership and demonstrated commitment to high ideals.

The 2018 U.S. Presidential Scholars are comprised of one young man and one young woman from each state, the District of Columbia and Puerto Rico, and from U.S. families living abroad, as well as 15 chosen at-large, 20 U.S. Presidential Scholars in the Arts and 20 U.S. Presidential Scholars in Career and Technical Education.

Created in 1964, the U.S. Presidential Scholars Program has honored almost 7,500 of the nation's top-performing students with the prestigious award given to honorees during the annual ceremony in Washington. The program was expanded in 1979 to recognize students who demonstrate exceptional talent in the visual, literary and performing arts. In 2015, the program was again extended to recognize students who demonstrate ability and accomplishment in career and technical education fields.

The 2018 ceremony will be held June 24, when each honoree will receive a Presidential Scholar Medallion.

SkillsUSA Montana is pleased to announce one if the 20 U.S. Presidential Scholars in Career and Technical Education is Tyler Noyes, SkillsUSA member from Broadwater High School. Congratulations to Tyler, his family and his advisor, Mr. Clint Watson.

U.S. Secretary of Education Betsy DeVos was in Louisville on June 28, touring the SkillsUSA Championships with Kentucky Gov. Matt Bevin and Lt. Gov. Jenean Hampton.

SkillsUSA executive director Tim Lawrence hosted the walking tour of the national competition for the trio, who also met with students and business partners participating in the conference at the Kentucky Exposition Center.

"I know all of you in red blazers appreciate this gathering as an opportunity to share ideas, compete on the floor, take part in leadership workshops, network with peers and discuss ways to prepare all students for today's and tomorrow's careers," said Secretary DeVos.

The 2018 conference included 102 contests to showcase a wide range of technical, service and health skills such as welding, culinary arts, cosmetology and nursing. The SkillsUSA Championships is the nation's largest workforce development event for middle-school, high-school and college/postsecondary students enrolled in public career and technical education programs. With an estimated \$36 million total value of industry-donated time, equipment, materials and prizes, the event is one of the largest single days of corporate volunteerism in America.
