


## Percentage of High School Students Who Did Not Always Wear a Seat Belt,\* 2003-2023<sup>†</sup>


## Percentage of High School Students Who Rode with a Driver Who Had Been Drinking Alcohol,\* 2003-2023<sup>†</sup>






## Percentage of High School Students Who Carried a Weapon on School Property,\* 2003-2023<sup>†</sup>





## Percentage of High School Students Who Were Threatened or Injured with a Weapon on School Property,\* 2003-2023<sup>†</sup>






### Percentage of High School Students Who Were in a Physical Fight,\* 2003-2023<sup>+</sup>


## Percentage of High School Students Who Were in a Physical Fight on School Property,\* 2003-2023<sup>†</sup>


## Percentage of High School Students Who Were Ever Physically Forced to Have Sexual Intercourse,\* 2003-2023<sup>+</sup>






## Percentage of High School Students Who Experienced Physical Dating Violence,\* 2013-2023<sup>+</sup>




## Percentage of High School Students Who Were Bullied on School Property,\* 2009-2023<sup>†</sup>






## Percentage of High School Students Who Seriously Considered Attempting Suicide,\* 2003-2023<sup>†</sup>

### Percentage of High School Students Who Attempted Suicide,\* 2003-2023<sup>+</sup>










