Section 20-1-101, MCA, is amended to read: 12 "20-1-101. Definitions. As used in this title and in administrative rules implementing this title, unless 13 the context clearly indicates otherwise, the following definitions apply: 14 (1) "Accreditation standards" means the body of administrative rules governing standards such as: 15 school leadership; (a) 16 (b) educational opportunity; 17 academic requirements: (c) 18 (d) program area standards; 19 (e) content and performance standards; 20 (f) school facilities and records; 21 (g) student assessment; and 22 (h) general provisions. 23 (2)"Aggregate hours" means the hours of pupil instruction for which a school course or program is offered or for which a pupil is enrolled. 24 25 (3)"Agricultural experiment station" means the agricultural experiment station established at 26 Montana state university-Bozeman. 27 "At-risk student" means any student who is affected by environmental conditions that negatively (4)28 impact the student's educational performance or threaten a student's likelihood of promotion or graduation.

20	<u>(12)</u>	"Financial literacy" means financial knowledge and skills, including but not limited to:	
21	<u>(a)</u>	managing a bank account, including how to complete routine banking activities online;	
22	<u>(b)</u>	understanding the psychology behind money decisions, including the basics of behavioral	
23	economics;		
24	<u>(c)</u>	learning how investing can create long-term wealth;	
25	<u>(d)</u>	understanding the basics of various types of credit, including credit cards, auto loans, and	
26	mortgages;		
27	<u>(e)</u>	learning how to manage credit responsibly, including the basics of credit scores and how to	
28	build credit from scratch;

5	(i) learning the mechanics and basic elements of a budget;		
6	(j) acquiring consumer skills such as:		
7	(i) learning how to avoid scams and fraud;		
8	(ii) protecting oneself against identity theft; and		
9	(iii) analyzing advertising and social media and how it can affect our financial behaviors;		
10	(k) understanding local tax assessments;		
11	(I) computing interest rates by various mechanisms;		
12	(m) comprehending simple contracts;		
13	(n) contesting an incorrect billing statement; and		
14	(o) navigating state and federal laws concerning finance.		
15	(12)(13) "K-12 career and vocational/technical education" means organized educational activities that		
16	have been approved by the office of public instruction and that:		
17	(a) offer a sequence of courses that provide a pupil with the academic and technical knowledge		
18	and skills that the pupil needs to prepare for further education and for careers in the current or emerging		
19	employment sectors; and		
20	(b) include competency-based applied learning through advanced opportunities, work-based		
21	learning partnerships, and other experiential learning opportunities that contribute to the academic knowledge		
22	higher-order reasoning and problem-solving skills, work attitudes, general employability skills, technical skills,		
23	and occupation-specific skills of the pupil.		
24	(13)(14) (a) "Minimum aggregate hours" means the minimum hours of pupil instruction that must be		
25	conducted during the school fiscal year in accordance with 20-1-301 and includes passing time between		
26	classes and, in an offsite instructional setting, includes time spent logging on and off an offsite learning		
27	platform.		
28	(b) The term does not include lunch time and periods of unstructured recess.

(14)(15) "Offsite instructional setting" means an instructional setting at a location, separate from a main school site, where a school district provides for instruction to a student who is enrolled in the district.

(15)(16) "Principal" means a person who holds a valid class 3 Montana teacher certificate with an applicable principal's endorsement that has been issued by the superintendent of public instruction under the provisions of this title and the policies adopted by the board of public education and who has been employed by a district as a principal. For the purposes of this title, any reference to a teacher must be construed as including a principal.

(16)(17) "Pupil" means an individual who is admitted by the board of trustees pursuant to 20-5-101 and who is enrolled in a school established and maintained under the laws of the state at public expense. The eligibility of pupils and calculations for average number belonging are governed by 20-9-311.

(17)(18) "Pupil instruction" means the conduct of organized learning opportunities for pupils enrolled in public schools while under the supervision of a teacher. The term includes any directed, distributive, collaborative, or work-based or other experiential learning activity provided, supervised, guided, facilitated, or coordinated under the supervision of a teacher that is conducted purposely to achieve content proficiency and facilitate the acquisition of knowledge, skills, and abilities by pupils enrolled in public schools, and to otherwise fulfill their full educational potential.

(18)(19) "Qualified and effective teacher or administrator" means an educator who is licensed and endorsed in the areas in which the educator teaches, specializes, or serves in an administrative capacity as established by the board of public education.

(19)(20) "Regents" means the board of regents of higher education.

(20)(21) "Regular school election" or "trustee election" means the election for school board members held on the day established in 20-20-105(1).

(21)(22) "School election" means a regular school election or any election conducted by a district or community college district for authorizing taxation, authorizing the issuance of bonds by an elementary, high school, or K-12 district, or accepting or rejecting any proposition that may be presented to the electorate for decision in accordance with the provisions of this title.

(22)(23) "School food services" means a service of providing food for the pupils of a district on a nonprofit basis and includes any food service financially assisted through funds or commodities provided by the

2 (23)(24) "Special school election" means an election held on a day other than the day of the regular school election, primary election, or general election.

- (24)(25) "State board of education" means the board composed of the board of public education and the board of regents as specified in Article X, section 9, subsection (1), of the Montana constitution.
- 6 (25)(26) "State university" means Montana state university-Bozeman.
- 7 (26)(27) "Student with limited English proficiency" means any student:
- 8 (a) (i) who was not born in the United States or whose native language is a language other than 9 English;
  - (ii) who is an American Indian and who comes from an environment in which a language other than English has had a significant impact on the individual's level of English proficiency; or
  - (iii) who is migratory, whose native language is a language other than English, and who comes from an environment in which a language other than English is dominant; and
- 14 (b) whose difficulties in speaking, reading, writing, or understanding the English language may be 15 sufficient to deny the student:
  - (i) the ability to meet the state's proficiency assessments;
- 17 (ii) the ability to successfully achieve in classrooms in which the language of instruction is English;

- 19 (iii) the opportunity to participate fully in society.
- 20 (27)(28) "Superintendent of public instruction" means that state government official designated as a
  21 member of the executive branch by the Montana constitution.
- 22 (28)(29) "System" means the Montana university system.
  - (29)(30) "Teacher" means a person, except a district superintendent, who holds a valid Montana teacher certificate that has been issued by the superintendent of public instruction under the provisions of this title and the policies adopted by the board of public education and who is employed by a district as a member of its instructional, supervisory, or administrative staff. This definition of a teacher includes a person for whom an emergency authorization of employment has been issued under the provisions of 20-4-111.
- 28 (30)(31) "Textbook" means a book, digital resource, or manual used as a principal source of study
