Montana Office of Public Instruction | School Nutrition Programs Updated July 2025

The USDA requires School nutrition program directors, regardless of LEA size, must complete eight hours of food safety training: either within five years prior to their start date or within 30 calendar days of their start date. The State agency may also require all directors to complete eight hours of food safety training every five years (7 CFR 210.30(b)(1)(v)). Montana requires that school food service managers complete a certification process for safe food handling.

A list of approved Certified Food Protection Manager training programs can be found at <u>Montana Department of Health and Human Services</u>, Food and Consumer Safety Division, Certified Food <u>Protection Manager Training</u>. Each of the following training is approved in Montana to meet the Certified Food Protection Manager requirement of the Food Code.

Please note, while the Serv Safe certification course has typically been the most common choice for Montana schools, each of the following programs are approved in Montana.
