- Your SketchUp Pro license is platform agnostic, which means the license codes will work on both Mac or Windows machines.
- A Single license code for each corresponding version of SketchUp Pro is provided for use on all school computers within your locality - the same code can be used for individual teacher computers, school lab computers, or school laptops.
- Each time a license is applied to a computer, that computer is node-locked with one license activation from the total pool of license activations (we have provided your state with plenty of activations).
- Computer Tech Administrators: To authorize multiple computers at once, this is your imaging workflow: Review the steps in this Knowledge Center article to see how to use the "activation_info.txt" file. Go to the section titled, Authorizing SketchUp on a Network as an Administrator.
- Computers need to be connected to the internet when authorizing SketchUp Pro. Internet connectivity is not required after SketchUp Pro has been successfully authorized.

- Your schools are welcome to use any of the aforementioned versions of SketchUp as long as those licenses have not yet expired.
- Please refer to our <u>SketchUp website</u> and <u>Knowledge Center</u> for <u>download</u> and <u>install</u> instructions, <u>training materials</u>, <u>getting started guides</u>, <u>video tutorials</u>, and more.
- Please be sure to keep these codes within your school or district. They are not to be shared with schools of higher education, facilities personnel, or other government departments/officials/staff/parents.
- Please do not post the license code on any publicly accessible site.
- Grant Licenses cannot be used for commercial (for-profit) work of any kind.
