- Begin Rulemaking Process for <u>standards 10.53.414 to 10.53.426</u> through consensus. Working documents can be found on the OPI home page, as well as a link that has been sent to all committee members. Consensus is based on committee agreement, and dissent requires a workable proposal.
- Discussion of changing "Montana Indigenous Peoples" to include tribes and Indigenous Peoples outside of Montana – consensus reached to keep "Montana Indigenous Peoples" since it prioritizes language in Montana Constitution and study of Montana Indigenous Peoples, matches the language of the adopted math standards, and does not exclude other tribes
