I am writing in response to the Montana Office of Public Instruction's (OPI) request on June 10, 2019, to amend its approved consolidated State plan under the Elementary and Secondary Education Act of 1965 (ESEA), as amended by the Every Student Succeeds Act. I have determined that the amended request meets the requirements in the ESEA and, for this reason, I am approving Montana's amended State plan. A summary of Montana's amendment is enclosed. Any further requests to amend Montana's ESEA consolidated State plan must be submitted to the Department for review and approval.

Please be aware that approval of Montana's consolidated State plan is not a determination that all the information and data included in the State plan comply with Federal civil rights requirements, including Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans with Disabilities Act, and requirements under the Individuals with Disabilities Education Act. It is Montana's responsibility to comply with these civil rights requirements.

Please note the submission of the approved amendment to the consolidated State plan also fulfills the terms of the condition the Department placed on Montana's fiscal year 2018 Title I, Part A grant. As a result of the approval of this amendment, the condition is removed.
