ESA Families,

The program has had a strong start, with reimbursements processing smoothly and making a positive impact on Montana families as they support their children's education. Currently, the Education Savings Account is supporting 14 students on their educational journey.

We are pleased that the second round of applications for new families opened on November 1, 2024, and will close on December 1, 2024. We have already received considerable interest from new families interested in participating in the program. Things to Know:

Mileage Reimbursement - If you transport your child to and from tutoring sessions or therapy appointments, you can be reimbursed for the mileage. Use the reimbursement form available on our **ESA** website. Mileage will be reimbursed at the current state rate of .67 cents per mile. When completing the form, you will be required to provide the starting and ending locations, the number of miles traveled, the date of travel, and the reason for the trip.

Mileage Reimbursement Form

Private School Tuition – If a parent chooses to utilize the ESA funds for private school tuition, in accordance with 20-7-1708, MCA, the Office of Public Instruction is required to collect quarterly reports of services provided to the qualifying student under this program. To comply with this requirement, the private school must provide quarterly reports to OPI confirming the student's enrollment dates and services provided. If we do not receive these reports, the Office of Public Instruction may not be able to provide reimbursement to the parent of the ESA student. The direct link where these quarterly reports can be uploaded is now available on the ESA Website.

Student Trust Account Deposits - The student trust accounts receive monthly deposits. These payments are made to OPI, from the school district, from September through June, and deposited into the students trust account monthly. By the end of June, students will have received the full allocation designated to their account. If reimbursement requests exceed the



current balance in the account, the remaining balance will be paid out in the following month, after the new deposits have been received.

Reimbursement Process - The reimbursement request form is located on the ESA Website. Families can submit reimbursement requests for allowable expenses incurred on/after July 1, 2024. Reimbursement requests submitted by the 25th of the month will be applied to the available balance for reimbursement the following month. Currently, we have sent out reimbursements for submissions by August 25th, and September 25th, and are in the process of sending out reimbursements sent in before October 25th.

As soon as we have more information, we will be sharing this out to families along with instructions
