## **FAQs - Teaching Traffic Education in Montana**

**Questions and Answers about Endorsement and Approval** 

Based on 10.13.310 Administrative Rules of Montana (ARM)

- 1. What is required in Montana to become a traffic education instructor and teach driver education?
  - □ A valid Montana educator license issued by the Office of Public Instruction (OPI), Educator Licensure Unit.
  - Approval as a teacher of traffic education issued by the <u>OPI Traffic Education</u> (TE) Unit, with each renewal of teacher's Montana educator license.
  - □ Initially, a minimum of 8 semester hours of credit coursework in traffic safety education leading toward a 20 semester credit minor. The initial 8-semester-hour block must include a classroom and behind-the-wheel traffic education teacher preparation course.
  - □ **To renew approval, 4 TE credits are required**. For each succeeding renewal of the Montana educator license, the teacher must accumulate an additional 4 semester hours of qualifying coursework that leads toward the TE minor requirements. Once the minor is achieved a TE endorsement may be awarded.
  - □ A valid driver license and acceptable driving record (ARM 10.13.310).

#### 2. Do I need a Montana educator license to teach traffic education?

Yes. Any valid Montana educator license is allowed by state law. Visit <u>OPI Educator Licensure</u>. In addition, the Traffic Education Office at OPI needs to "approve" the teacher's readiness to teach traffic education when the teacher submits the TE05 Teacher Application initially and with each renewal of their educator license.

#### 3. Once I obtain a TE endorsement, do I continue to apply for approval to teach traffic education?

Yes. The TE approval and TE endorsement are not the same. After a TE endorsement is earned and appears on the educator license, no additional TE coursework is required. However, to renew approval to teach driver education, the instructor must meet the cyclical requirements for educator license renewal and submit the TE05 form to the OPI Traffic Education Unit for TE approval.

A responsible driving record is required in addition to the approval requirements to be licensed and endorsed for Traffic Education. An instructor's driving record is reviewed each year the instructor teaches traffic education. If an instructor does not maintain an acceptable driving record in accordance with Administrative Rules of Montana 10.13.310, their approval to teach will be revoked until such time that they are in compliance. Teachers meeting the conditions for approval will receive a letter of approval from the Traffic Education Director.



**4. Are there professional development opportunities for traffic education instructors?** Yes. The Montana Traffic Education Association (MTEA) is an active and supportive organization that offers many benefits to traffic education teachers. MTEA hosts an annual conference in a different Montana city each year and one college credit is available for full participation in the conference. #### 5. Where can I take the required traffic education courses to obtain a TE minor?

Montana State University-Northern (MSUN) in Havre is the only Montana institution that offers a TE minor. The goal is to complete 20 semester credits in traffic education



requirements. Several online courses are available each summer (and other courses may be offered year-round upon inquiry). Contact MSUN about cooperative efforts with other Montana universities that offer traffic safety-related courses and combining coursework from another college or university to qualify for the TE endorsement. *See contact information below.* 

## 6. Can Montana educator Renewal Units be used toward completing the coursework required for a TE minor and TE endorsement?

No. Renewal units do not qualify as college coursework, and, therefore, do not qualify toward the TE minor. However, MSUN often offers college credit for qualifying conferences and workshops. If an individual signs up for the qualifying TE credit, pays the fees, and completes the assignments, the earned college credit may apply toward the minor. TE instructors may not receive college credit and Renewal Units for the same workshop or conference; only obtain one or the other.

#### 7. Are there exceptions to the TE approval process?

Yes. State policy allows exemptions for emergency or extenuating circumstances if a school district is without a driver education instructor. In both cases, the objective is to assure continued TE instruction by qualified individuals and facilitate the completion of the TE endorsement by the teacher.

Both types of exemptions require documentation that the school has advertised the TE teacher vacancy without success and no other qualified instructors are available. In the case of the one-time, one-year emergency extension request, the instructor must outline how the deficient coursework will be completed during the following year.

In very unusual cases, an emergency extension of up to two years may be granted. For this one-time option, the instructor must also show how they will complete the TE minor and obtain the TE endorsement by the end of the extension period.

## **Steps to Traffic Education Approval & Endorsement**

The Traffic Education Endorsement is granted when a teacher has earned at least 20 credits (12 required, 8 elective) in Traffic Education and Safety from MSU-Northern. A teacher can receive

approval to teach state-approved traffic education in Montana if they have:

- 1. a current and active Montana educator license,
- 2. an acceptable driving record and valid driver license, and
- 3. has earned at least 8 of the 12 required college credits in traffic education and safety toward a Traffic Education Endorsement from MSU-Northern.

A **TEO5 Application for Approval as a Teacher of Traffic Education** must be submitted to OPI the year the approval expires (usually the same year the educator's license needs to be renewed). At least 4 credits must be earned during each five-year renewal period. When 20 or more credits have been earned, the teacher will receive a Traffic Education Endorsement from OPI and no additional college credit is required for future approvals.

With an endorsement, traffic education teachers still have to reapply every 5 years and have an acceptable driving record to be approved to teach traffic education.

Educator licenses need to be renewed by June 30 in the renewal year. Traffic Education approval must be renewed

by September 30 of the renewal year.

Approval to teach traffic education must be renewed when you renew your Montana educator license, usually every five years. + 4 Credits Traffic Ed course work = APPROVAL

How to earn required college credits?

• Complete an online or on-site traffic education course at MSU-Northern in Havre.

• Attend the spring Montana Traffic Education conference and write a paper.

• Participate in a MT DRIVE Workshop and stay an extra day to student teach.

### + 4 = 20 Credits Traffic Ed course work = ENDORSEMENT

When 20 or more Traffic Education credits are completed for the Traffic Ed Endorsement:

Contact MSUN once you have completed your Traffic Education Endorsement.

Request an official transcript from the MSUN Registrar's Office to be sent to OPI Licensure.

The MSUN Certification Officer will complete the necessary paperwork and forward it to OPI Certification to add the Traffic Education Endorsement to your educator license.

## **ROAD MAP FOR NEW TRAFFIC EDUCATION TEACHERS**

### YOU ARE HERE: MSU-Northern at Havre

Complete the initial traffic education coursework (8 credits or more). MSUN will send letter and Traffic Education Program Sheet to Traffic Education Office at the OPI.



DONE! Initial traffic education coursework and credits earned.

## NEXT STOP: Office of Public Instruction, Traffic Education Office



Submit *TEO5 Application for Approval to Teach Traffic Education* to OPI Traffic Education. <u>Approval granted when MSUN notifies OPI that student has passed initial courses</u>. OPI Traffic Ed will check to see that your Montana educator license is active and current, your driver license is valid, and your driving record is free of disqualifying citations. Approval letter will be sent to you with copy for school district administrator. Keep this letter for future reference.

**DONE!** Approval to teach traffic education in the state of Montana.

## **NEXT STOP:** <u>School District's Traffic Education Program</u>

When you are hired as a traffic education instructor at a Montana public or private school, check to make sure the district has submitted a *TEO1 District Application* to the OPI. If they already have an approved traffic education program for the current fiscal year, make sure your name is added to the TEO1 application. Also, make sure you send an email to <u>pborneman@mt.gov</u> to request access to the Traffic Education Data & Reporting System (TEDRS) so you can manage your traffic education program online (send name, phone, email and school district).



DONE! Teacher added to approved TE01 District Application.
DONE! Teacher has username to access OPI's TEDRS online reporting.

### **NEXT STOP:** Motor Vehicle Division, Department of Justice



When you attended courses in Havre, you were trained in and passed the Cooperative Driver Testing Program (CDTP) test. You CANNOT administer the CDTP tests until the following **two forms** are sent to the MVD/DOJ and you are officially CDTP-certified. This certification will show up in TEDRS.

1) <u>School District Intent to Participate in CDTP</u> and 2) <u>CDTP Instructor Compliance Affidavit.</u>

These forms document **where** you are administering the CDTP exams and ensure that all parties understand the security responsibilities of this cooperative arrangement.

## Application for Approval as a Teacher of Traffic Education

**HOW TO APPLY**: To receive approval as a teacher of traffic education in the State of Montana, complete and return this application to Traffic Education at the Office of Public Instruction (OPI). Upon approval, your instructor record will be updated and two copies of your approval letter will be mailed to you.

**DEADLINES:** This approval must be renewed with each renewal of your Montana educator license. Your educator license must be renewed **before June 30**; your approval to teach traffic education must be renewed **before September 30**.

Still working toward your traffic education minor? Request a Traffic Education Program Sheet from MSU-Northern and a copy will be forwarded to the OPI. Complete the course information in Item 6 below [10.13.308(3) ARM] and submit this form to the OPI when your educator license has been renewed. Or you can submit your renewal application via the OPI website at <a href="http://opi.mt.gov/Driver-Educators">http://opi.mt.gov/Driver-Educators</a>.

Already have your TE endorsement? Just submit a TE05 Renewal Application following renewal of your educator license.
