Example how to budget indirects:

Indirect Cost Rate %
----- X Total award less capital outlay less resource transfers passed through to other districts
1.00 + Indirect Cost Rate %

Assume rate is 3.23%

Amount to Budget As Indirect = $\frac{.0323}{1.0323} \times 19,000 \text{ (award)} - 1,000 \text{ (equip)} - 8,000 \text{ (subgrants)}$

Amount to Budget As Indirect = .0313 X 10,000

Amount to Budget As Indirect = \$313.00
