

## SY 2025-26 Sponsors to Conduct the Error-Prone (Standard) Verification Method

Due to having a low response rate (less than 80% of households responded) during last year's free & reduced verification process, the following sponsors must conduct the error-prone (Standard) Verification method during SY 2023-24 and select 3% of the approved application to verify from those considered 'error-prone'.

An error-prone applications is within \$100 per month or \$1,200 annually of the annual Income Eligibility Guideline cut off points. It is recommended that sponsors needing to conduct the error-prone method of verification identify F/R applications considered 'error-prone' upon originally approving or ensure utilized software is capable of identifying error-prone applications for the verification process.

Verification Sample Methods		
Do not include applications already confirmed as directly certified in the total count of applications that are in the pool of those subject to verification as their eligibility has already been confirmed from the program source.		
<b>Error-Prone (Standard)</b>	Error-Prone (Standard) method required if less than 80% of the household apps responded to last year's verification process.	3% of all applications approved as of Oct 1, selected from error prone applications.
<b>Random (Alternate One)</b>	May conduct the Random (Alternate One) method if 80% or more of the household apps responded to last year's verification process.	3% of all applications approved as of Oct 1, selected at random.
<b>Focused (Alternate Two)</b>	May conduct the Focused (Alternate Two) method if 80% or more of the household apps responded to last year's verification process.	1% of all applications approved as of Oct 1, selected from error-prone applications. PLUS .5% of applications approved as of Oct 1, selected from categorically eligible applications (household provided case # or categorical program on app) but NOT directly certified in DCA.
