Call for Public Comments (The chair of the panel may, at their discretion, allow public comment during the course of the meeting.)

Deva McNiven asked if the Panel can comment or if it is just meant for people outside the Panel. Danni said outside, but Patrick said we could, and Danni said as long as it is understood that the Panel does not comment, and the Public Comment is put in the notes.

In the October 2023 meeting Deva said it was stated that there are very few lawsuits against the state or districts which she applauds, and thinks is wonderful. The thing she wanted to bring to attention is that many of the things that could be prosecuted, for lack of a better word, are either being placated or condescended or outright intimidated and parents don't feel like they will be heard or that they have that avenue or that there will be repercussions to them doing that and, "while I wish that wasn't the avenue parents had to take I believe those concerns should not be shoved under the table just because we don't have a million lawsuits coming to our state." Deva has been told by many different people that she should have sued her district many times over the years because her IEP's have not been fulfilled. She has chosen not to do that because she believes the people she has worked with at her local level are working hard for her students. She has a hard time prosecuting people who she believes are working for the best interests of her students. That does not change the fact they have not been receiving student services that they should have been receiving. "This is a problem with our educational system. It is not a people problem or an administrative problem. It is a problem from the very top of our country's educational system that needs to be changed and I don't think parents need to file lawsuits to be heard." If that is the only way to be heard she is going to tell people to do it. She doesn't want to be unjust, but she is afraid she will have to file a lawsuit in the next few years or even this year. That is the end of Deva McNiven's Public Comment.
