- Using the <u>Submit Student List Template</u> and <u>Submit Student List Instructions</u>, NAEP School Coordinators will work with their school's data provider to complete the template.
- Once the template is complete, NAEP School Coordinators will submit via the <u>Montana File Transfer</u> <u>Service</u>. <u>Instructions</u> are available on the website.
