Review of Modernization Project

- Modernization Project Status Presentation
 - Review of current activities
 - Assessment Documents delivered to OPI
 - Accreditation addition to TeachMT product
 - Chatbot RFP being reviewed by DOA
 - Connected Intelligence (Data Lake)

- Qualtrics Survey Tool / Comprehensive Needs Assessment (CNA)

 - CNA result requests can be completed by District Superintendents
 - Are CNA questions separated by stakeholder group?
 - Yes, each stakeholder group have different sets of questions.

 - Were there several CNAs in the past?
 - Yes, in the past there have been several CNAs provided by the OPI.
 - OPI staff worked to reduce question duplication by combining all CNAs into one comprehensive survey.
 - Are there sample reports that the districts receive of their data?
 - The data is not owned by the OPI. If individuals would like to see copies
 of district data, you will need to reach out to the district superintendent to
 request those results.

 - Better understand hot topics in the field
- Website Updates
 - Currently hosted by DotNetNuke (DNN)
 - Granicus will no longer be considered as a viable option to be hosted by in the future
 - OPI will be assessing other platforms to determine if another platform can better accommodate the agency's needs
