

Unified Insights: Essentials	The statewide security solution for Unified Insights is on the critical path to be able to complete the Unified Insights implementation in November 2024. To stay on track, the solution will need to be finalized				
	and set up by the end of July. Currently, OPI is having issues with the				
	setup and has opened up a support ticket with Microsoft to				
	troubleshoot. OPI has also asked for help from PowerSchool.				
	PowerSchool will discuss internally and respond to the request as soon				
	as they have an update. Given this delay, the solution will most likely				
	not be ready by the end of July, which will push the November timeline				
	out.				
	A blocker that was identified and resolved previously was				
	communicated by OPI again on 7/11. Until this blocker is resolved,				
	PowerSchool will not be able to move forward with loading data from				
	the iC State Edition to Unified Insights. This blocker is also on the critical				
	path to be able to complete the implementation in November 2024.				
	Historical context: PowerSchool replicated the approved tables from the				
	iC State Edition in April. This data is the source for Unified Insights. To				
	be able to load data to Unified Insights we need a complete and correct				
	source of system-district-school data. It was determined in April by OPI,				
	and a risk created, that the table available to us in the iC State Edition				
	did not have what was needed due to source data issues. OPI identified				
	a new source of district data. This new table was replicated in May and				
	a crosswalk was developed so that we could move forward with the				
	Unified Insights data load. On 7/11 OPI let PowerSchool know that the				
	new table that was identified was deprecated and that we would need				
	to use a new table that is available in the iC State Edition. This table was				
	not previously approved to be replicated. PowerSchool will need to				

Connected Intelligence	replicate this additional table and re-work the crosswalk solution based on this update. Once the crosswalk blocker is resolved, PowerSchool will continue with the work to configure the iC connector to load data to Unified Insights. OPI will continue to work on finalizing a viable option for a statewide security solution. OPI will set up a meeting with the assessment team to review assessment questions. OPI and PowerSchool are presenting at the SAM Administrators Institute on July 24 th . OPI is planning to have internal discussions around the communications, training, and rollout plan.					
Connected Intelligence	PowerSchool reviewed options internally to determine the best way to move forward with the GEMS replication given the requirement that only specific tables should be replicated directly from the source. An update will be communicated to OPI. OPI submitted required information to PowerSchool to move forward on the setup for the VPN to replicate PS SIS data for the first on-prem district. In the next reporting period, PowerSchool will complete GEMS replication and the VPN for the first on-prem district. On Hold: PowerSchool is on hold with replicating data from PS SIS to CI for districts with PS SIS due to the requirement that we only replicate the same data elements that OPI collects from the iC districts. To do this, PowerSchool will need to move forward with building a custom connector instead of using the standard connection for the PS SIS replication. This work is lower priority than the UI work. After completing UI, PowerSchool will scope out development work, cost, and timeline for this customization.					
Unified Insights: Other Modules	Waiting for GEMS replication to be completed as noted above. Once GEMS is replicated, a separate project plan will be built for Community Engagement. PowerSchool will be able to determine a target date for completion at that time.
