
Objective	Goal
Broadband Deployment	Utilize Federal Funding to develop Broadband infrastructure
Broadband Access	Decrease percentage of unserved locations from 13% to 0% Decrease percentage of underserved locations Increase percentage of Montana residents with access to internet-capable devices
Broadband Adoption	Increase household adoption rates
Broadband Affordability	Increase percentage of eligible households enrolled in the Affordable Connectivity Program Increase percentage update of affordable plans
Digital Opportunity	Increase household adoption rates within covered populations
Economic Growth and Job Creation	Increase percentage of business locations with high-speed internet access


- Program Benefits

  - Service discount up to \$75/month on qualifying Tribal lands
  - Device discount up to \$100 for a laptop, tablet, or desktop computer
