# REPORT ON THE MONTANA COUNCIL ON EDUCATIONAL OPPORTUNITY FOR MILITARY CHILDREN

September 2024

#### **OVERVIEW**

As required by <u>20-1-231</u>, <u>MCA</u> this report provides a summary of the state's participation in the Interstate Compact on Educational Opportunity for Military Children and the activities and discussions of the Montana Council on Educational for Military Children during the 2023-2024 school year. This report and other information associated with the council are posted on the Office of Public Instruction's website.

# **PURPOSE**

In 2013, the Montana Legislature approved <u>Senate Bill 203</u>, which enacted into law the Interstate Compact on Educational Opportunity for Military Children. The purpose of the Interstate Compact is to remove barriers to educational success imposed on children of military families due to frequent moves and deployments of their parents. The state's participation in the compact is intended to facilitate:

- the timely enrollment of children of military families;
- the student placement process;
- the student's qualification and eligibility for enrollment, educational programs, and extracurricular academic, athletic and social activities; and
- the student's on-time graduation.

#### **COUNCIL MEMBERSHIP**

One of the requirements of participation in the Interstate Compact is for each state to create a council on educational opportunity for military children. The members of the Montana Council on Educational Opportunity for Military Children for the 2023-2024 school year include:

In 2021, Governor Gianforte appointed Ray Shaw, Ret. Seargeant (USAF) as Compact Commissioner. He is responsible for the administration and management of the state's participation in the compact. The Interstate Compact provides for the uniform treatment of military children transferring between states and school districts. Commissioner Shaw traveled to Richmond, Virginia to participate in the Military Children Interstate Children's Compact Commission Annual Business Meeting (MIC3 ABM) to report on behalf of Montana's state council. School Liaison, Lisa Sapp, was unavailable to attend this year's ABM. Montana's 2023 end of year report can be located <a href="here">here</a>. The Interstate Compact's 2023 annual report will be posted, all previous year's reports can be viewed <a href="here">here</a>. During his visit to the 2023 ABM, Commissioner Shaw shared with other state's commissioners the progress the Montana council has made in advocating and supporting military connected students.

In 2020, the Montana council voted to adopt the Purple Star School designation program. This program recognizes Montana schools that display extraordinary commitment to supporting military-connected students and families. As of this year, there are a total of 12 Purple Star Schools designated across Montana. In 2021, the award was expanded to include Purple Star

- 2. Offer training and education opportunities for educators to learn about the challenges facing military-connected students and their families with the goal of fostering and eliminating barriers to their academic success.
- 3. Continue the encouragement and sponsorship of activities across Montana in partnership with Malmstrom, the Montana Air National Guard, and the Montana Army National Guard in celebration of Purple Up! Day, which commemorates military families in our communities.
- 4. Disseminate resources made available by the Interstate Compact and the Department of Defense in an effort to provide additional outreach to military families statewide.
- 5. Continue to collaborate with military stakeholders and identify legislative opportunities to aid and assist military families residing in Montana.
