Requirements for Montana Class 1 Educator License

- Hold a bachelor's degree from a regionally accredited college or university;
- Hold a master's degree in education or an endorsable teaching area from a regionally accredited college or university;
- Completion of an educator preparation program which is accredited by NCATE, CAEP, MACTE or is a state approved program from a regionally accredited college or university. Completion of supervised teaching experience through an educator preparation program needs to be posted to official transcript **OR**
- Completion of a National Board Certification program **OR**
- Completion of a non-traditional teaching program with 5 years of out-of-state teaching experience as a licensed teacher at any level within a state accredited P-12 school system; along with a current, standard, unrestricted out-of-state educator license

Submit each of the following:

1. **Score report** verifying completion of the Montana required Praxis test with the minimum qualifying score(s) meeting Montana standards for your endorsement area(s).
2. **Certificate** of completion of the free online course "An Introduction to Indian Education for All in Montana."
3. **Official transcript(s)** verifying completion of a bachelor's degree and a master's degree from a regionally accredited college or university in education or an endorsable area **OR**
 - **Certification** by the National Board for Professional Teaching Standards.
4. **Verification of Teaching Experience** form verifying 3 years of teaching experience. If you completed a non-traditional teaching program, you will need to verify 5 years teaching experience.

Important Considerations:

- To obtain a Class 1 Educator License in Montana applicants must submit verification of all of the above. If you cannot qualify for a Class 1 license, a specialist will consider your application for a provisional license.
- If your teaching experience was in a private/non-state accredited school, it will not meet the requirements for Class 1 licensure.

How to Initiate Your Fingerprint Background Check

Per FBI regulations, the Office of Public Instruction (OPI) cannot accept fingerprint-based background check results that were processed for any purpose other than for Teacher Licensure.

Fingerprints must be clear. Smudged or unclear prints will be rejected by the FBI. Therefore, we recommend that you complete and submit two fingerprint cards, to ensure that your background check can be completed in a timely manner.

Instructions

1. Go to **your local law enforcement agency** or any other agency offering fingerprinting services. Request that your fingerprints be taken for a background check. There may be a charge for this service. Remember to have two fingerprint cards completed.
 - If you will be fingerprinted at the Montana Department of Justice in Helena, please use their online scheduling system to make your appointment. Visit their home page at <https://dojmt.gov/> and follow the link for fingerprint appointments at the bottom of the page.

Professional educators recognize and accept their responsibility to create learning environments to help all students reach their full potential. They understand the trust and confidence placed in them by students, families, colleagues, and the community. To achieve their professional purpose, educators strive to maintain the highest ethical standards. The Professional Educators of Montana Code of Ethics sets out these fundamental principles which guide their behavior.

Principle I. Commitment to Students and Families. The ethical educator:

- A. Makes the well-being of students the foundation of all decisions and actions.
- B. Promotes a spirit of inquiry, creativity, and high expectations.
- C. Assures just and equitable treatment of every student.
- D. Protects students when their learning or well-being is threatened by the unsafe, incompetent, unethical or illegal practice of any person.
- E. Keeps information confidential that has been obtained in the course of professional service, unless disclosure serves a compelling purpose in the best interest of students, or is required by law.
- F. Respects the roles, responsibilities and rights, of students, parents and guardians.
- G. Maintains appropriate educator-student relationship boundaries in all respects, including speech, print, and digital communications.

Principle II. Commitment to the Profession. The ethical educator:

- A. Fulfills professional obligations with diligence and integrity.


