

Subject: Year 2 MAST Form B Summative Pilot: Important Updates and Next Steps 4.19.24 MAST Outreach

A friendly reminder that the first week of testing has concluded. If you haven't already done so, please schedule and complete all assigned testlets during the testing window. Please allow time for student make-up testing. The testing window will close on *May 10, 2024*.

Test Administration Support

Instructions regarding testlet assignment and administration are provided to support your staff in understanding the process of administering MAST Form B testlets. There are three different forms for each testlet that are randomly assigned to students. Each testlet will appear three times in the Test Monitor screen but only one Daily Access Code is needed to access the one testlet the student will take. Daily Access Codes matching the testlet names will grant students access to their respective testlets.

For ELA, students will only take *one* Testlet 1 (either informational *or* literary—randomly assigned to students). Students will take *both* Testlet 2 (information *and* literary). All students will take the ELA Performance Task. Students will take *one* Testlet 3 (either informational *or* literary—randomly assigned to students).

End Test Session Button

There have been inquiries regarding the functionality of the End Test Session Button. Clicking this button in the Test Monitor Screen will force submit all student testlets, transitioning testlets that are "In Progress" or "Unused" to "Completed" status. Once testlets are in the "Completed" status, students will no longer be able to access them. It's important to note the distinction between the End Test Session button in the Kite Portal and what districts may be accustomed to from Smarter Balanced. By clicking the End Test Session button in the Test Monitor Screen, testlets will no longer be accessible to students. Therefore, it's crucial to use this button only when all students have completed testing, including absent students or students taking a testlet in a separate setting per the student's IEP/504.

Math Anchor Testlet

During the fifth and final testing window, the math anchor testlet will be administered. Please ensure this testlet is the last administered math testlet. The assessment consists of 20-22 questions in two sections. Students in grades 6-8 may not use a calculator for Section 1. Students in grades 6-8 may use the calculator tool provided in Kite for Section 2 only. The calculator is accessible in the Student Portal Toolbox. Students may not use any other calculator for this assessment unless approved by your school. On the Review/End page of Section 1, students will select CONTINUE to launch Section 2. Be sure students check their work in Section 1 before moving to Section 2. Once the second session is launched, students will be unable to go back to Session 1. 
Using the Dashboard

Using the Test Monitor Screen

For a more detailed testlet completion monitoring, users can refer to the test monitor screen to view completion numbers as seen in the slide below:



Once in the Monitor screen, you can see which testlets are Complete (submitted) and which are still In Progress or Paused (not submitted). To filter students that are in-progress, paused, or unused (meaning they have not initiated the testlet), select the three dots on the Overall Status column to sort descending. From your list of students identified as in-progress, paused, or unused, you will be able to finish administering the testlets to these students. If you find that a student is no longer enrolled in your district, please reach out to the OPI Assessment Help Desk to manually exit them from the Kite Portal.

MAST Accommodations

A MAST accommodation drop-down menu has been added to Infinite Campus. Districts have the option to start making changes to student IEPs if desired. Alternatively, districts can choose to use the <u>MAST Accommodations Crosswalk Document</u> to translate current SBA accommodations into MAST PNPs. A <u>MAST Accessibility Guide</u> is now available to help provide guidance and support when making testing accommodations decisions for students.

2. User Interviews: Share your insights and feedback on various aspects of testlet configuration, reporting, and testlet design through individual interviews.

3. Focus Groups: Join focus groups aimed at discussing specific components of the assessment and providing input for improvement.

State Enrollment Updates

State enrollment updates will continue daily within the testing window to capture any students transferring into your district. Please be sure to keep your district's Student Information System (SIS) up to date. If you are using Infinite Campus, it automatically syncs with the state databases to update student enrollment information in an overnight cycle. However, if you are using Powerschool, please note that it requires a manual sync with the state to update student enrollment information in an overnight cycle. Please be sure to roster these students right away in the Kite Portal. It may take up to 24 hours for testlets to assign after rostering has occurred.

MAST Form B Test Administration Manual

Notification of Testing Parent Letter

In accordance with our standard practice for statewide assessments, it is mandatory for school districts to inform parents or guardians about scheduled assessments. To assist you in effectively communicating with parents or guardians regarding the MAST Pilot, please find this linked <u>Parent Letter Template</u>. This template will serve as a helpful guide in notifying parents or guardians about the upcoming assessment and providing them with relevant information.

Full MAST Participation

During the extended field testing of MAST, it is crucial to closely monitor testlet completion. Per the Federal Testing Waiver granted to Montana for the 2023-2024 MAST administration, districts that fully participate in MAST are exempt from taking the Smarter Balanced Assessment.

Form B Participants:

 Each school is expected to assess all eligible students at a participation rate of at least 95% in accordance with section 1111(c)(4)(E)(iii) within the final testing window (April 15-May 10). Full participation includes completion of all assigned testlets.

- Schools not completing assigned testlets with fidelity may be required to take the Statewide Summative Assessment.
 - If individual students are not able to complete assigned testlets due to a medical reason, districts are to report non-participation through the MontCAS Application in accordance with <u>state assessment policy</u>.

One Writing Task testlet: includes two moderately complex texts that the students have seen in the middle-of-year testlets, 5 items that focus on informational or literary reading skills, and 1 item that assesses writing skills. The writing prompt will be specifically designed to target writing and language standards, assessing aspects such as organization/purpose, development/support, and knowledge of language and conventions. FREQUENTLY ASKED QUESTIONS

What are the expectations for our district's Testing Plans if we are MAST Participants? If selected for monitoring, districts are mandated to submit five essential testing plans to ensure test security. These encompass the Test Administration Plan, Test Accessibility Plan, Test Security Plan, Data Use Plan, and Test Training Plan. For MAST participating districts, please update any references to the Smarter Balanced Assessment, replacing them with appropriate language for MAST in the existing plans. This ensures alignment with your district's participation in the MAST Pilot.

Do we still administer the Montana Science Assessment?

Districts participating in both subgroups of the MAST Pilot are still required to administer the Montana Science Assessment (MSA) to students in grades 5 and 8. Any alternate students you may have enrolled this year will need to take the Multi-State Alternate Assessment (MSAA) (Grades 3-8 and 11) and the Alternate Montana Science Assessment (AMSA) for Grades 5, 8, and 11 as there is not an alternate version of MAST.
