



Maximum Retainable Oil and Gas Production Taxes

FY 2017

The maximum amount of oil and natural gas production taxes that a school district may retain is 130% of the school district's maximum general fund budget, determined in accordance with 20-9-310 MCA allocation and limits.

The limit on oil and natural gas production taxes that a school district may retain under subsection (1) must be increased for any school district with an unusual enrollment increase approved by the superintendent of public instruction as provided in 20-9-314 MCA. The increase in the limit on oil and natural gas productions taxes that a school district may retain under subsection (1) applies in the year immediately following the fiscal year in which the office of public instruction has approved the district's unusual enrollment increase and must be calculated by multiplying \$45,000 times each additional ANB approved by the superintendent of public instruction as provided in 20-9-314 MCA.
