- ESSER Closeout of ESSER II. Now in cash request mode, and districts are submitting the cash requests until October 25, then final reports due until November 10. Cannot do a cash request and final expenditure during the same month.
- ESSER III- moving into ESSER III and working with districts throughout the year rather than just the at the end of the year for funding purposes.
- Districts are currently completing and submitting the **ESSER self-assessment**. Already have 35 submitted! This includes narrative spaces for districts to submit narrative comments as well as yes/no components. Please include those important extra notes as needed. It is a required document and is district-level (not school). This report takes all ESSER I, II, and III into account.

October Compass Highlights for Superintendents

- MAST pilot program year 2-** from 5000 students to 25000 students in this pilot. In 24-25 school year all schools will be in pilot. No longer administering SBAC. First testing window is October 23. This information is going directly to schools in the pilot from Tressa Graveley. Site coordinators are rostering. There is a Form B, for schools who are not involved in the existing pilot, schools can opt into a Form B “summative” timeframe, where they can do the pilot in the summative at the end of the school year, and not have to do SBAC.
- Overview of statewide assessment results from last year.
- Early Literacy Collaborative:** In the 2023 Legislative Session, Montana lawmakers passed HB 352, authorizing the establishment of targeted early literacy interventions. To support the intent of collaboration stated in the bill, the OPI is creating an Early Literacy Collaborative (ELC). This Collaborative will foster cooperation between government agencies, schools,

families, educators, educator preparation programs, and communities. The focus of the OPI's collaborative will be to provide guidance for implementation of the school and home-based literacy intervention programs determined by the Board of Public Education. In addition, the ELC will provide data and feedback to the Board of Public Education's Early Literacy Advisory Council. The OPI's ELC will meet virtually monthly, starting in mid-October.
