PROGRAM HIGHLIGHTS

Montana Aligned to Standards Through-Year (MAST)

MAST testing in grades 3-8 for math and ELA general population students begins on October 13, 2025.

All schools must make any changes and confirm math testlet alignment through the Testlet Scheduler before September 15, 2025. Support for additional tasks including user management, rostering, and entering student supports and accommodations, can be found in [Before Testing Tasks](#).



Montana Science Assessment (MSA)

The MSA will continue to be the general population science assessment required in grades 5 and 8, administered in the spring. User and student management, test administration, and reporting is found in the Montana Testing Portal.

Dynamic Learning Maps (DLM)

Starting this year, 3-8 and 11th grade students eligible and identified to take alternate assessments will take the DLM math and ELA assessments in an instructionally embedded model in the fall and spring. Students in grade 5, 8, and 11 will take the DLM science assessment in the spring testing window.

Please keep IEPs for all students locked throughout the school year, including students identified to take alternate assessments. Unlocking IEPs affects portal uploads.

WIDA ACCESS

All K-12 students identified as English Learners are required to take the WIDA ACCESS or Alternate WIDA ACCESS from January 5-March 6.

Ensure ELs are marked in your district's student information system to ensure materials are ordered and students are included in the upload to WIDA AMS testing portal prior to testing.

ACT

The ACT with Writing will be the required statewide assessment for math, ELA, and science for the 2025-2026 school year for all grade 11 students (unless alternate) and will be administered online.

NAEP

Montana is participating in NAEP in the areas of Math & reading in grades 4, 8, and 12. Schools selected for each assessment will be contacted by the NAEP State Coordinator.

Updated plan checklists are found on the Test Security page of the [OPI Statewide Testing](#) website. Testing plans are due by September 1, 2025 and are required to be uploaded through the MontCAS Application.



REQUIRED TEST SECURITY SCREENS within the MontCAS Application

Each district STC must complete both test security screens by September 1, 2025. Find Focused Support Videos for both screens in the Test Security tab on the [Stay Informed Page](#) of the Statewide Testing website.

2025-2026 OUTREACH FOR TEST COMPLETION SUPPORT

The OPI Assessment Team will provide general and completion outreach throughout each testing window to ensure every student has the opportunity to complete each required statewide assessment.

Prior to each testing window and during the initial weeks of testing, a general reminder will be emailed to each district STC with reminders of essential tasks for administration.

As each testing window comes to a close, additional notices will be sent to the STC, Superintendent, and principal of each school with low completion rates to support the completion of all testing.

TESTING AND REPORTING NOTIFICATION REQUIREMENTS

School districts are required to notify parents/guardians of the planned assessments prior to administration as well as the time and format for disseminating assessment results including individual student reports.
