### **Welcome and Review Norms and Expectations**

#### **Counselor to Administrator Pathway Review**

- 2. TF is supportive of presented language and recommends the language go to the Superintendent.

### **ARM Subchapter Discussion and Feedback**

- Document shared with ARM Subchapters OPI identified as potential areas for review.
- 2. Discussion of Middle grades 4-8 endorsements in 10.57.102
  - a. How many cases fall under this?
    - i. Julie Murgel commits to coming next week with specific examples and more information
  - b. What does this mean in EPPs in Montana?
    - i. Angela McLean commits to speaking with EPPs to see what it would mean to prepare students for this endorsement.
  - c. Dan Schmidt makes comments that age level vs content level endorsements are separate
  - d. Julie and Crystal commit to finding information about the terminology restrictions for funding between PreK and EC
  - e. Shaun Scott suggests simplifying endorsement areas may create less barriers and more flexibilities for MT teachers.

- f. Discussion around having more or less endorsement areas could make it more flexible within the state but more difficult to move into the state from out of state.
- g. Conversation will be continued next week.
- 3. Discussion of Emergency Authorization of Employment 10.57.107
  - a. Examples of "repeat offenders" and barriers with emergency authorizations given by Crystal Andrews and Christine Eggars.
  - b. Angela McLean suggests utilizing preservice teachers to help fill emergency authorization needs in districts.
  - c. John Melick suggests MT lacks online options for uncertified individuals to work towards becoming certified.
  - d. Diane Fladmo requests data around how many EAs have been done and the trend lines
    - i. Crystal Andrews commits to gathering this for the next meeting.
  - e. Angela McLean volunteers to start writing language
  - f. Erich Stiefvater suggests looking at an alternative approach to look at provisional licenses through Class 2 licenses to accommodate needed change in EAs
  - g. Jacob Williams reminds the group of last week's conversation of possible pathways to licensure.
- 4. Discussion of Unusual Cases 10.57.109 notice of hearing in 30-day window
  - a. Crystal Andrews suggests the language "Notice of Hearing" into 10.57.109 like it is seen in 10.57.602
  - b. McCall Flynn is supportive of this change
  - c. McCall Flynn suggests adding language to be able to waive the right
  - d. TF is supportive of the suggestion
    - i. Crystal Andrews will provide a red line document with the suggested change for final vote.
- 5. Discussion of adding J1 visas to 10.57.112
  - a. Julie Murgel clarifies the definition and difference between exchange teacher and international teacher.
  - b. Is there some option to add a pathway to reduce the amount of time or be used until qualifications are met for international teachers?
  - c. Julie Murgel suggests there needs to be clarity in 10.57.112 or possibly repealing the section.
  - d. John Melick suggests speaking with SAMS about the language
- 6. Discussion of social workers, nurses, and speech hearing therapists
  - a. Suggestion from Crystal Andrews to leave 10.57.501 as is.
  - b. Angela McLean suggests this topic needs go be looked at further in Chapter 55 and 58.
  - c. TF has no objections to leaving 10.57.501 as is.
