
# Percentage of High School Students Who Ever Tried Cigarette Smoking,\* by Sex, Grade,\* and Race/Ethnicity,\* 2021




### Percentage of High School Students Who Ever Tried Cigarette Smoking,\* 1993-2021<sup>+</sup>




# Percentage of High School Students Who First Tried Cigarette Smoking Before Age 13 Years,\* 2017-2021<sup>†</sup>


# Percentage of High School Students Who Currently Smoked Cigarettes,\* by Sex, Grade,\* and Race/Ethnicity,\* 2021


### Percentage of High School Students Who Currently Smoked Cigarettes,\* 1993-2021<sup>+</sup>




#### Percentage of High School Students Who Currently Smoked Cigarettes Frequently,\* 1993-2021\*




#### Percentage of High School Students Who Currently Smoked Cigarettes Daily,\* 1993-2021<sup>+</sup>




#### Percentage of High School Students Who Smoked More Than 10 Cigarettes Per Day,\* 1993-2021<sup>+</sup>






### Percentage of High School Students Who Currently Used an Electronic Vapor Product,\* 2015-2021<sup>†</sup>




# Percentage of High School Students Who Currently Used Electronic Vapor Products Frequently,\* 2015-2021<sup>†</sup>



## Percentage of High School Students Who Currently Used Electronic Vapor Products Daily,\* 2015-2021<sup>†</sup>







## Percentage of High School Students Who Currently Used an Electronic Vapor Product on School Property,\* 2019-2021<sup>†</sup>






#### Percentage of High School Students Who Currently Used Smokeless Tobacco,\* 2017-2021<sup>+</sup>



# Percentage of High School Students Who Currently Used Smokeless Tobacco Frequently,\* 2017 - 2021<sup>+</sup>





#### Percentage of High School Students Who Currently Used Smokeless Tobacco Daily,\* 2017-2021<sup>+</sup>






#### Percentage of High School Students Who Currently Smoked Cigars,\* 1999-2021<sup>+</sup>


### Percentage of High School Students Who Currently Smoked Cigars Frequently,\* 1999-2021<sup>+</sup>

# Percentage of High School Students Who Currently Smoked Cigars Daily,\* by Sex,\* Grade,\* and Race/Ethnicity, 2021






### Percentage of High School Students Who Currently Smoked Cigars Daily,\* 1999-2021\*


#### Percentage of High School Students Who Currently Smoked Cigarettes or Cigars,\* 1999-2021<sup>+</sup>












## Percentage of High School Students Who Currently Smoked Cigarettes or Used Electronic Vapor Products,\* 2015-2021<sup>†</sup>
