Assessment

MontCAS News

The Assessment Division sends school leaders tailored monthly messages on the Montana Comprehensive Assessment System (MontCAS) via the Assessment 411 electronic mailing system and are posted on the OPI Statewide Testing page of the OPI website. This month the issue had three reminders on (1) the Smarter Balanced online-only score reports (note: more information available during the April 15th live MontCAS Monthly Webinar at 3:30 pm), (2) reaping the benefits of Smarter Balanced interim (note: view the recorded webinar at MontCAS Monthly Webinar), (3) the importance and local responsibilities for test security (note: more information available during the March 18th live MontCAS Monthly Webinar at 3:30 pm). As of February 18th, 60% of school systems had fulfilled the required MontCAS Application System-Level Test Security Agreement Collection in accordance with the published MontCAS Test Security Collection Schedule.

Assessment Bulletin News

The Assessment Division sends school system test coordinators monthly newsletters via the OPI Assessment Bulletin which are posted on the OPI Statewide Testing page of the OPI website. This bulletin is tailored to the test coordination responsibilities at each school system. This month the issue had three takeaways including the interim predictive research as shared with school leaders in the Assessment 411. The other two takeaways were specific to gearing up for the testing windows through (1) ensuring student enrollment information and educational plans are updated and locked in AIM/Infinite Campus and (2) reviewing the student eligibility and participation policies as listed on the OPI website.

ACT

All Montana juniors enrolled in accredited Montana schools take the state ACT with Writing, with the first test date of March 24. School staff can refer to the Montana ACT <u>Schedule of Events</u> for information about enrolling new students, requesting late accommodations, setting up for online testing, as well as dates and deadlines for activities related to the administration of the assessment.

School Election Deadlines

- Friday, March 6th: Mail ballot plan, timetable, and sample instructions must be received by the Secretary of State's office. Forward a copy, including any amendments, to the county election administrator.
- Monday, March 9th: Verify that the county election administrator has published the notice at close of regular registration.
- Thursday, March 26th through Saturday, April 25th: Notice of election is posted. The notice must be published in a newspaper of general circulation (if one is available within the district), in three public places, and on the district's website (if active) for the 10 days prior to the election. The notice must include the date and voting locations, voting location hours, each proposition to be considered, the number of trustee positions and length of terms, where and how absentee ballots may be obtained, and where and how late registrants may obtain a ballot on election day.
- Thursday, April 2nd (by 5:00 pm): Last day trustee candidates may withdraw from the election and the deadline for write-in candidates to file a Declaration of Intent.
- Friday, April 3rd: Deadline to notify election judges of appointment.

- Friday, April 3rd: Election administrator certifies the ballot. Any resolutions stating exact levy amounts must be passed by this date.
- Friday, April 3rd: The trustees may call the election by acclamation, cancel the election and give notice that the election will not be held.

FY 2019 Federal Audit Reports Due to OPI March 31st

The Federal Audit Reports (formerly A-133 audits and required by 2 CFR Part 200) are due to the OPI by March 31, 2020, for entities that have federal expenditures of \$750,000 or greater, which include USDA commodities. FY 2019 Yellowbook Audits (regular audit) are required for entities with all revenues totaling more than \$750,000 are due to the OPI by June 30, 2020. FY 2019 Reviews (Agreed Upon Procedures) are required at least every four years for entities with \$750,000 or less revenues, are due to the OPI by June 30, 2020.

Extended Stop Arms on Montana School Buses

The OPI has received several inquiries regarding the installation and use of extended stop arms on Montana School Buses.

The 2018 Montana School Bus Standards <u>CLICK HERE</u> references FMVSS Standard No. 131; School Bus Pedestrian Safety Devices on page 35 #1. Upon thorough review, as well as information received from NHTSA, we have concluded that the installation of the extended stop signal arms are allowable. FMVSS 131(c) states the stop arm must be a minimum of 9" from the side of the bus, however, it does not state a maximum in length. Working on developing your school's Emergency Action Plan? Do you have questions about what should be included in the plan? There is no such thing as a "one size fits all" when going through the planning process to develop your plan. Although sharing of ideas and concepts from other school districts is highly encouraged, these pieces of information from outside of your school still need to be vetted by your school's safety planning group to ensure the plan input fits in with your school's situation and policy.

Licensure Requirements – New and Renewal

As you are preparing to fill vacancies with applicants who may not yet be licensed as a Montana educator, specialist or administrator, a quick summary of the minimum licensure requirements for each position are found in the corresponding sections:

Considering Employing a Foreign National?

If you are considering employing a foreign national, a vital step for you in this process before offering employment is for you to review an equivalency evaluation of their foreign educator preparation program that has been completed by a US foreign evaluation credentialing agency. This agency determines the equivalency of their foreign educator preparation program to a US educator preparation program. The agency provides the results of their evaluation in the summary section; this information is what Licensure relies on for determining licensure qualification and the appropriate endorsement area. The National Association of Credential Evaluation Services (NACES) is a great resource for this process. The process for a foreign national to apply for licensure is available heres.

Renewing a Montana educator license?

A reminder that those whose license(s) expire June 30, 2020, may complete the online renewal process at any time after the first of the year in which their license expires.

A minimum total of 60 renewal units are needed (college courses are not required but may be used: 1 quarter credit = 10 renewal units; 1 semester credit = 15 renewal units).
