Updates in Montana Education

Our state is incredibly proud of Linda and her accomplishments. Beginning in February, the process will start all over again to find Montana's 2021 Teacher of the Year, check out our website and nominate one of your awesome teachers!

Update on DPHHS Rules Affecting Schools

DPHHS's new <u>administrative rules</u> were filed with the Secretary of State on January 7th. The OPI and education partners met with DPHHS and DEQ on January 17th for the first communication planning meeting to coordinate information and resources for schools. We want to ensure that schools have one point of contact and are not bombarded with reach outs from different agencies. As we compile resources and solidify communications plans, we will keep you updated. Please feel free to reach out if you have any questions.

OPI Digital Communications

Federal Education Funding

On December 19th, President Trump signed a federal funding bill to fund the federal government through September 30, 2020. Below are the education allocations. NOTE- most education programs are forward funded. We will have Montana's funding projections available later this spring.

The Labor-HHS-Education bill provides a total of \$72.8 billion for the U.S. Department of Education, a \$1.3 billion increase over FY2019 funding:

- \$16.31 billion for Title I (increase of \$450 million over 2019)
- \$12.76 billion for IDEA Part B grants to states (\$400 million increase)
- \$2.13 billion for Title II (\$76 million increase)
- \$1.21 billion for Title IV-A (\$40 million increase)
- o \$1.25 billion for 21st Century Community Learning Centers (\$28 million increase)
- o \$1.28 billion for Career and Technical Education (\$20 million increase)
- \$787 million for Title III, English Language Acquisition (\$50 million increase)
- \$33 million for Statewide Longitudinal Data Systems (\$700,000 increase)
- o State assessment grants are level-funded at \$378 million.
 - o The Impact Aid program also saw a \$40 million increase to \$1.49 billion.

Outside of ED funding, this spending deal also includes:

- o Increases in the HHS budget of \$550 million each for Head Start (\$10.6 billion total) and the Child Care and Development Block Grant (\$5.8 billion)
- o \$7.6 billion for the 2020 Census
- Increased funding for rural broadband access

Assessment

ACCESS for ELLs Test Window

Schools across Montana have been administering the ACCESS for ELLs English Language Proficiency assessment since December 4, 2019. The ACCESS for ELLs Test Window closes on Wednesday, January 29, 2020. Currently, the only test administration monitoring occurring is the ACCESS for ELLs monitoring. If your school district is selected, you will be contacted by the OPI and asked to provide testing date (<u>Testing Date Tool</u>) information for the purpose of this visit.

Smarter Balanced Interim Use Across Montana

The Smarter Balanced interim use is highest in January and February across districts. The current number of completed interims as of the middle of January 2020 is 24,044, compared to 10,320 completed interims a year ago at the same time and 3,985 completed interims in January 2018. Research from the Montana Data Use Culture grant has shown that students that have taken the interims prior to taking the summative state assessment are likely to have performance gains. Some districts are starting to use interims in the high school grades as well.

Science Assessment Development

Progress continues with the development of the Montana Science Assessment and its alternate. Practice tests for both have been posted on the <u>Montana testing portal</u>, and new documents on the assessments and accommodations will be posted in the Resources tab as they become available.

ASSIST Conference

The <u>OPI Data and Assessment Conference</u> was held in Helena, MT at the Delta Hotel on January 13 and 14, 2020. Over 250 educators, school test administrators, and district personnel were in attendance. During the 2-day conference, session presenters shared some of the best practices for using data appropriately to inform instruction while ensuring educators are successful in administering the Montana statewide assessments. Montana Student Privacy Alliance Launched

The OPI is proud to announce the launch of the Alliance. The Alliance was created in response to the 2019 Montana Legislature's passing of House Bill 745 and is the direct result of the cooperation with and efforts of the Montana Educational Technologists Association, the School Administrators of Montana, and the Montana School Boards Association (MTSBA). House Bill 745 requires all Montana school districts to ensure their technology software and/or services (for example, apps, websites and other software) that collect or otherwise use student information have contracts and agreements in place that contain very specific language around protecting student data and privacy.

School officials and staff can visit the <u>Montana Student Privacy Alliance website</u> to help them better understand and meet these new requirements. The site offers training videos, <u>links to the Montana Student Data Privacy Consortium</u> (where sample vetted agreements are housed) and other information to help schools protect student information and preserve student privacy.

The Montana State Plan outlines **5 indicators** that are used for the accountability system. Currently, the Montana OPI is researching measures of school quality for the 5th Indicator. After the research phase, we will be reaching out this Spring (2020) to collaborate and consult with our partners in education on this component of the ESSA plan.

1-4 Federally Required Indicators

- Academic Achievement on Statewide Assessments: ELA/Reading & Math
- Academic Growth on Statewide Assessments ELA/Reading & Math (K-8 Only)
- English Learner Progress
- Graduation Rates (HS only)

5th Indicator for Montana Flexibility: School Quality or Student Success Indicator

- Attendance
- College & Career Ready (HS Only)
- CRT Science Assessment (2016-2017)

The 5th Indicator is addressed on pages 24-26 of the Montana State Plan, which reads, "The OPI will be creating a measure of school quality that takes into account high quality implementation of these programs and practices. This measure will be weighted at five points within the system. The OPI will submit this survey to the Department of Education once it is developed and will not use it in the accountability system until it is developed and approved."

FY 2019 Federal Audit Reports Due to OPI March 31, 2020

The Federal Audit Reports (formerly A-133 audits and required by 2 CFR Part 200) are due to the OPI by March 31, 2020, for entities that have federal expenditures of \$750,000 or greater, which include USDA commodities. FY 2019 Yellowbook Audits (regular audit) are required for entities with all revenues totaling more than \$750,000 are due to the OPI by June 30, 2020. FY 2019 Reviews (Agreed Upon Procedures) are required at least every four years for entities with \$750,000 or less revenues, are due to the OPI by June 30, 2020.

Application for an indirect cost rate does not increase the amount of the grant award. Please review the instructions and additional documentation for more details.

If you reclassify costs to adjust the indirect cost rate, please read the Indirect Cost Rate Instructions prior to reclassification of costs for an adjusted rate. Costs that may be reclassified are highlighted in blue. A reclassification calculator is available for aiding in the determination of an adjusted indirect cost rate.

Transformational/Advanced Opportunities

The Board of Public Education Qualifies Advanced Opportunities Applications

The Board of Public Education qualified 33 districts, at their January 17, 2020 meeting. Nine of the 33 districts will receive FY 2021 funding. The remaining districts have a firm place on the priority list for FY 2022 funding. The priority list can be accessed on the OPI website's Advanced Opportunities Act (HB 387) page.

The appropriation for FY 2021 was \$750,000.00. The appropriation for FY 2022 is projected to be \$1,649,057. All districts on the current priority list and new applicants would be funded in FY 2022 with this appropriation amount. The window for FY 2022 opens on the first Monday in December 2020 and closes in January 2021.

Transformational Learning Grant Window Opens February 3

The Transformational and Personalized Learning Grant window for FY 2021 opens February 3, 2020 at 8:00 a.m. and closes February 21, 2020 at 5:00 p.m. Districts who are applying for the first time or districts that are already funded but looking to increase their FTE for the second year of funding, should remember that this is a first-come, first-served application process. All application submissions are time and date stamped. The appropriation for FY 2021 is projected to be: \$1,588,070.00.

First-Come, First-Served Process Feedback

The Interim Education Committee questioned the effectiveness of the first-come, first-served process in both of these legislative bills during their January 16, 2020 meeting. The rationale behind the method was to ensure that any size district would be able to compete for funding. .
