Updates in Montana Education

Legislative Session

The legislative session is past the halfway point and the outlook for education funding appears to be much more positive than the last biennium. Many of the reductions from the 2017 regular and special sessions are restored in the current state budget bill (HB 2) and the record \$77 million inflationary increase to K-12 BASE Aid has been signed into law. In addition to funding, legislation addressing school safety, CTE, special education, educator recruitment & retention, and other programs are still working their way through the legislature. Comment Period Open on ESSA State Plan Amendment

Previously, under NCLB, states were required to provide a definition of a "highly qualified teacher." Under ESSA, states are required to submit a definition for "ineffective teacher" to the U.S. Department of Education through an amendment to our state ESSA plan. The OPI's proposed definition is: "Montana teachers who are non-licensed or show a pattern of ineffective practices as determined by a local evaluation". However, Montana is a local control state and the OPI will not collect a new data point for local evaluations. The OPI will host a Q&A conference call to discuss this proposed amendment on April 4th at 9am. The call-in number is (641)-552-9164 and the code is 514145.

If a school is in Advice or Deficiency accreditation status for 2018-2019, a corrective plan will be due by June 1, 2019. This requirement is indicated on the 2018-19 Accreditation Status report for each school. If the school is in <u>Comprehensive support</u>, no corrective plan is required. The Corrective Plan application is located on the <u>OPI School Accreditation website</u>.

Digital Content Providers Registered in MT Annual Reporting

Pursuant to Administrative Rules of Montana (ARM) 10.55.907(5)(b), registered digital content providers serving Montana schools are required to provide an annual report to the Montana Office of Public Instruction by **June 1, 2019**. See below for Administrative Rules of Montana requirements for content providers:

ARM 10.55.907(5) - Distance, Online, and Technology Delivered Learning:

- "(5) Digital content providers serving Montana schools accredited by the Board of Public Education shall:
 - (a) annually, by the first Monday in August, register with the Office of Public Instruction;
 - (b) annually, by the first Monday in June, identify the Montana school districts served in the current school year by the digital content provider, including the courses and student enrollments for each school district served; and
 - (c) document the professional qualifications, including Montana teacher licensure and endorsement, of their teachers of distance, online, and technology-delivered programs and/or courses by providing names and credentials of other licensing entities, when not licensed and endorsed in Montana."

- Thursday, April 4th (by 5 pm): Deadline for candidate withdrawal, deadline for write-in candidates and deadline to notify election judges of appointment
- Friday, April 5th: Election administrator certifies the ballot *or* Election by Acclamation and cancellation of election
- Monday, April 8th: Close of regular voter registration and contact county election administrator for absentee ballot list
- Tuesday, April 9th: Start of late voter registration
- Thursday, March 28th through Saturday, April 27th: Notice of election is posted
- Wednesday, April 17th: Absentee ballots available
- Wednesday, April 17th through Monday, April 22nd: Mail ballots mailed

Essential Understandings Regarding Montana American Indians

The Essential Understandings Regarding Montana Indians has been updated and is now available. The Essential Understandings are some of the major issues all Montana tribes have in common. They were originally developed in 1999. This booklet will be sent to school libraries later this month.

This revised version was completed in conjunction with educators from across Montana including several of the original participants from the 1999 meetings - Norma Bixby (Northern Cheyenne), Julie Cajune (Salish), and Joyce Silverthorne (Salish). The review process included members of the Montana Advisory Council for Indian Education. Special thanks go to Dr. Heather Cahoon (Pend d'Oreille) who synthesized the comments and input received during our revision process and provided additional background information. The updated version includes key concepts and detailed background information for each Essential Understanding.
