## USDA Continues to Offer Flexibilities for 2021-2022

The US Department of Agriculture 2021-2022 school year waivers for schools will continue to offer flexibility in feeding children and meeting local needs. These waivers are available for schools across the state regardless of student eligibility or in-person learning status.

Many of these flexibilities are extensions of existing waivers. The Summer Food Service Program (SFSP) option was not extended for schools into the 2021-2022 school year. Instead, a new waiver will allow school districts to access the Seamless Summer Option (SSO). Typically, schools operate the National School Lunch Program (NSLP) during the school year. The SSO program removes student income eligibility requirements providing free meals for all students and will provide the higher SFSP reimbursement. While very similar to the SFSP option that schools have been using since March 2020, the SSO requires schools to follow the NSLP meal pattern and complete the application and reimbursement forms under the NSLP section of MAPS.

The Montana Office of Public Instruction is currently making administrative and technology changes to existing systems to accommodate the Seamless Summer Option (SSO) to align with the federal waivers. The MAPS update is tentatively scheduled to be in place by June 18th, 2021. After the update, schools will be able to login to MAPS, complete their NSLP application packet, and opt into the SSO via the site applications section.

#### Youth Risk Behavior Survey School-Specific Results Available

The 2021 Youth Risk Behavior Survey (YRBS) was completed by students in schools this past winter. Results for the Middle School and High School school-specific and district-wide (for AA districts) results are now available!

#### To view your results:

- Go to <u>www.opi.mt.gov/yrbs</u> and select "View School-Specific Results"
- 2. On the <u>YRBS Data Retrieval System</u> log-in screen enter your OPI Common Log-In (OCL) username used for other apps. This is usually your first name initial and last name (ex. SCourt)
- 3. Enter your password or click on the 'forgot password' button. A password will be e-mailed to you; copy and paste it into the log-in screen.
- 4. Once into the system you can change your password to something more user-friendly (passwords expire every 90 days.)
- 5. Select the year (2021) and school(s). This is a PDF file that can be saved to your computer.

The travel cost including hotel, breakfast, lunch will be paid by OPI and an additional mini-grant funding will be awarded to districts participating to cover stipends, mileage, and evening meals. We need to limit your teams to 6 people so all schools in comprehensive can participate. However, if space becomes available, we will send out an email stating how many spots we have open and more team members can sign up. We also highly recommend you include your business clerk to attend with your leadership team. It will be an opportunity for him/her to hear the overall plans of your district.

# Waiver to the ESSA Accountability System

Montana applied and was granted accountability and school identification waivers on March 26, 2021, which are important as they provide relief from the impact of COVID-19 on the accountability system for the 2020-2021 school year. In particular, they waive the requirements to:

- Measure progress toward long-term goals and measurement of interim progress;
- Meaningfully differentiate, on an annual basis, all public schools, including by adjusting the Academic Achievement indicator based on a participation rate below 95 percent;
- Identify schools for comprehensive, targeted, and additional targeted support and improvement based on data from the 2020-2021 school year; and
- Report provisions related to accountability based on data from the 2020-2021 school year.

# Implications of the ESSA Accountability Waiver

While the OPI is waiving accountability requirements, we are committed to providing technical assistance and professional learning to our schools to support transparency and reporting needs for students, families, and educators. The OPI will:

- Continue to maintain or improve transparency in reporting to parents and the public on student achievement and school performance in school year 2020-2021, including the achievement of subgroups of students;
- Make publicly available chronic absenteeism data on State and local report cards; and
- Collect and report data on graduation rates, college and career success indicators, attendance, and access to qualified educators data.

# Ongoing Support for Schools Identified Comprehensive or Targeted

All schools identified for comprehensive, targeted, and additional targeted support and improvement will continue to receive funding and support from OPI improvement specialists.

The OPI will identify comprehensive, targeted, and additional targeted support and improvement schools using data from the 2021-2022 school year in the fall of 2022/spring of 2023 to ensure school identification resumes as quickly as possible. Under ESSA, the OPI will continue to advocate for school communities and students, recognizing that the changes this year for accountability, identification, and reporting do not preclude Montana from submitting amendments or additional waivers to gain greater flexibility in the future.

# Novice Special Education Trainings

#### American Rescue Plan Act

On March 24, 2021, the Montana OPI received from the U.S. Department of Education (USED) the American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) Funds, authorized under the American Rescue Plan (ARP) Act. The ARP-ESSER provides \$382,019,236 (ESSER III) for Montana schools to safely reopen and sustain safe operations of schools while meeting the academic, social, emotional, and mental health needs of students resulting from the COVID-19 pandemic. This marks the third round of ESSER funding that Montana has received and is available through September 2024.

Following the release of the ARP-ESSER funding, on April 21, 2021, USED issued an application template for States to share how they will work with districts to monitor the use and impact of ARP ESSER funds. Through the ARP-ESSER State template, the requirements and timelines were set by the Department.

**Use of Funds:** Of the total amount allocated to an Local Education Agency (LEA) from the State's ARP ESSER award, the LEA must reserve at least 20 percent of funds to address lost instructional time through the implementation of evidence-based interventions and ensure that those interventions respond to students social, emotional, and academic needs and address the disproportionate impact of COVID-19 on underrepresented student subgroups. As of May 21st, the Department has not released the Use of Funds Guidance. As soon as the guidance is released, the OPI will make the information available on our website link listed above.

#### Montana's Virtual Academy Days

Every year, Montana's best and brightest apply for the opportunity to attend each of the elite United States Service Academies—the <u>U.S. Military Academy</u>, the <u>U.S. Naval Academy</u>, the <u>U.S. Air Force Academy</u>, the <u>U.S. Coast Guard Academy</u>, and the <u>U.S. Merchant Marine Academy</u>.

The United States Service Academies give students the unique opportunity to earn their bachelor's degrees while preparing for a career in the military, combining world-class education with the proud legacy of military service.

Service Academies routinely rank among the top universities in the nation. Students pay no tuition to attend, and are required to serve in the military upon graduation. Admission to an Academy is a competitive, two-step process. First, students must obtain a Congressional or Presidential nomination. Then, students receive an appointment from the individual Academy.

To be eligible to apply for a nomination to a Service Academy with a member of Montana's congressional delegation, you must meet the following initial requirements:

- Be a U.S. citizen.
- Be at least the age of 17, but less than 23 by July 1st of the year of matriculation.
- Be unmarried, not pregnant, and without legal obligation to support children or other dependents.
- Reside within the legal boundaries of Montana.

NOTE: If you are attending a service academy preparatory school, a university out of state, or have recently relocated out of Montana due to your parents' service in the military and maintain Montana as your permanent residence, you may still apply with the Montana delegation.

Applying to a United States Service Academy is a rigorous, highly-competitive and lengthy process—and Montana's congressional delegation is here to help. Montana's Academy and ROTC Days are hosted annually to connect students, parents, and educators with the infor-

mation and advice they need to successfully navigate the Academy nomination process. Due to coronavirus public health and safety concerns, this year's Academy days will take place virtually, via WebEx.

These calls will connect prospective students with Academy liaisons from the U.S. Military Academy, U.S. Naval Academy, U.S. Coast Guard Academy, U.S. Air Force Academy, U.S. Merchant Marine Academy, and ROTC, as well as representatives from each of Montana's congressional delegation. Any student looking for more information regarding the Academy experience or questions regarding the nomination process is encouraged to join.

#### K-12 Data Task Force Membership

The OPI is seeking your help in finding people interested in serving on the K-12 Data Task Force. The K-12 Data Task Force was created by the 2013 Montana Legislature through the adoption of 20-7-104, MCA and 20-7-105, MCA, and includes legislators, school board members, educators, school administrators, school technology staff and parents. The purpose of the K-12 Data Task Force is to advise and provide guidance to the Office of Public Instruction on the statewide K-12 data systems.

As most of you are aware, approximately \$13.5M in CARES and ARPA funding was appropriated this past legislative session to the OPI for the purposes of data systems modernization. You can learn more about the OPI's plan for data systems modernization by visiting our project webpage. As the OPI prepares and plans for this significant investment in and change to data systems, it's important to us that the K-12 Data Task Force is involved. We are anticipating quarterly meetings with the task force, and will also conduct numerous focus groups with specific audiences and stakeholders for at least the next year as we work together to gain cooperation and support. We expect the task force meetings to restart in late June with the Data Modernization Project as its main work and focus.

#### DEQ Announces 13 Clean School Bus Replacement Grants

Announcement Commemorates Air Quality Awareness Week

HELENA—The Montana Department of Environmental Quality (DEQ) has awarded 13 clean school bus replacement grants. The grants will help school districts replace older diesel school buses with newer diesel models to help reduce air pollution.

Older diesel buses release nitrogen oxides which can lead to asthma and respiratory illnesses, especially in children and elderly who are known to be at increased risk. DEQ's Clean School Bus Replacement program aims to reduce kids' exposure to harmful diesel exhaust from old diesel buses across the state.

"Montana is a rural state, and many parents depend on safe, reliable buses to get their children to and from their schools," said Superintendent of Public Instruction Elsie Arntzen. "These DEQ grants are a great way for these five school districts to ensure quality transportation for students in a cost-effective manner."

The grants awarded by DEQ are funded through the Environmental Protection Agency's Diesel Emission Reduction Act (DERA). This year's the grants were awarded to school districts in Billings, Hamilton, Kalispell, Vaughn and Grass Range.

"DEQ is proud to continue supporting Montana schools by helping them purchase cleaner buses that reduce children's exposure to harmful nitrogen oxide emissions. These new buses not only reduce pollution but are more efficient to operate, saving school districts money," said DEQ Energy Bureau Chief Dan Lloyd.

The announcement celebrates National Air Quality Awareness Week, May 3-7, which raises awareness of air quality issues such as impacts from wildfire smoke. The event also honored 6 outstanding recipients of the IEFA Advocacy Award and featured 5 students from tribal nations across Montana who are making positive contributions to their community by leading school and community improvement efforts and staying true to their tribal ways.

#### **HB** 702

HB 702, passed by Montana's 67th Legislature and signed by Governor Gianforte on May 7th, defined that it is an unlawful discriminary practice for a governmental entitiy to deny a person any services, goods, or advantages based on the person's vaccination status or whether the person has an immunity passport.

Superintendent Arntzen joined DPHHS Director Adam Meier in <u>sending a letter</u> to school officials and health-care providers on May 21st reminding them that students who are under 18 years of age will require a parent or legal guardian's consent to get a COVID-19 vaccine. The letter also encourages school administrators to proactively communicate with parents and legal guardians regarding parental consent requirements for vaccines should a district choose to host COVID-19 vaccine clinics in their schools.
