#### Smarter Balanced

The individual student score reports were sent to districts from Measured Progress. Per ESSA requirements, schools must send the student score results to parents in a timely manner. A new website, MT Starting Smarter, branded and customized for Montana and designed specifically for parents to help them better understand their students' Smarter Balanced score reports which went live on Monday, September 16<sup>th</sup>. Districts are encouraged to send this link to parents alongside the score reports.

The Assessment Roadshow is in full swing with visits in Dixon, Lewistown, Helena, and Miles City being conducted. The focus of this professional development is to promote balanced assessments including the Smarter Balanced interim assessments. Representatives from the OPI Assessment Division and the Content Standards and Instruction Division are conducting the trainings. All requests will be processed and considered by the OPI Assessment Team using key criteria.

# **Data and Technology**

#### **Discounts for Schools**

Did you know that public school districts may purchase supplies and services in cooperation with the State of Montana? This is called cooperative purchasing and often provides substantial savings to districts when compared to purchasing on their own. In addition to better pricing, it can also be faster and more efficient procurement by avoiding the bid and contract negotiation process districts would otherwise need to conduct. Cooperative purchase contracts typically have all the necessary terms and conditions already agreed upon and are ready to use by districts. The State of Montana requires that interested districts sign a Cooperative Purchasing Memorandum of Understanding prior to utilizing state contracts. This agreement must be signed by a school district official and returned to the State Procurement Bureau. Approved districts can purchase goods using the Montana eMarketCenter or can choose to purchase directly from the contract vendor.

### **Protecting Student Data Privacy**

The Montana Pupil Online Personal Information Protection Act was passed by the 2019 Montana Legislature and is also referred to as House Bill 745 (HB 745). All Montana school districts that use technology software and/or services (for example, apps, websites and other software) that collect or otherwise use student information are required to comply with HB 745. HB 745 requires the terms of services, agreements and contracts districts have with any technology service providers and operators to have very specific language that protects student data privacy.

The Montana Educational Technologist Association (META) and Office of Public Instruction are working together to start a Montana Student Privacy Alliance. The Alliance will be a resource for districts to find and share terms of service, agreements and contracts and be a place to find

approved vendors and products that comply with HB 745. The Alliance expects to also provide professional development to help parents, teachers and administrators make informed decisions about the technology being used in the classroom and help ensure we protect the data privacy of Montana students.

# **Every Student Succeeds Act (ESSA)**

### Comprehensive Support and Improvement

The 2019-2020 school year marks the second year of Comprehensive and Targeted Support and Improvement. Listed below are the improvement steps relevant to schools identified for Comprehensive and Targeted Support and Improvement that are taking place.

<u>Comprehensive Needs Assessment</u>: Conduct a CNA of both operational and instructional components. <u>CNA Link</u>

<u>Continuous School Improvement Plan:</u> Updating the CSIP with current state assessment data. The OPI will continue to provide guidance to schools in analyzing data, developing plans, and setting goals for literacy, math, and other items based on the school's needs. The OPI will also continue to assist schools with selecting and implementing evidence-based practices, strategies, and interventions. <u>CSIP Link</u>

<u>Fall Conference-October 7<sup>th</sup> & 8<sup>th</sup>:</u> The OPI will host a Title 1 School Support Fall 2019 Training at the Delta Hotels Marriott, in Helena. This will be an opportunity for CSI School Leadership Teams to refine and improve the implementation of the Continuous Improvement Cycle and Evidenced-Based Interventions with fidelity. Registration Link

<u>Family and Community Involvement:</u> The OPI will assist LEAs and schools in establishing structures for ensuring tribal, family and community involvement in all stages of the process, and with monitoring implementation and effectiveness.

<u>Tribal Consultation:</u> Guidance for LEAs to consult with American Indian tribes and tribal organizations on issues affecting American Indian students. The consultation process allows affected LEAs to gather input from tribes and tribal organizations, fostering the collaboration that is a critical part of improving academic outcomes for students.

<u>OPI Team:</u> Monthly, the OPI point of contact is working in partnership with school and district leadership teams. <u>OPI Contact List</u>

<u>Instructional Consultant:</u> Use of Instructional Consultants selected by the district to support schools.

### **Targeted Support and Improvement**

Schools identified for targeted support work in partnership with the district to conduct a Comprehensive Needs Assessment (CNA) of instructional components and develop a Continuous School Improvement Plan focused on academic goals and underperforming subgroups for the 2019-2020 school year. The OPI is available to support districts and schools in analysis of the CNA and drafting the CSIP, as well as, provide the following strategies for targeted support and improvement:

- Facilitation of Data Talks to support the gap analysis of the CNA and state assessment data and use of data as part of the continuous improvement cycle;
- Support with developing the Continuous School Improvement Plan, which includes clear measurable goals focused on subgroups;
- Systemic literacy and math improvements through regional trainings; <u>Math</u>
   <u>Professional Learning</u> and <u>ELA Professional Learning</u>
- Online courses focused on the identified subgroups through the Teacher Learning Hub;
- Ongoing support through OPI-sponsored conferences and website resources.

The OPI will be hosting a webinar on October 3<sup>rd</sup> from 10:00-11:00a.m., to review the support available to Targeted Support and Improvement Schools and specifically discuss the Data Talk process and application for a Formula Grant. Email invitations will be sent soon.

- September 15-Last day to Open/Create an E-Grant Application for SY2019-20 without approval from <u>Jule Walker</u>, Deputy Superintendent
- October 31-Districts must have a submitted and approved E-Grant Application.

New this year: Districts must import on or after October 8 in order to submit. This will give AIM staff the time to complete attendance prior to importing.

Extenuating circumstances for students who will be gone 10 days prior to the count date, but which would support a variance should be submitted to the OPI prior to the official enrollment count date for consideration of inclusion of the student in the enrollment count for ANB purposes beyond the 10th day of absence.

## **Reporting American Indian Students**

Students identified as American Indian in the AIM system at the time the data is imported into the MAEFAIRS fall count will generate funding for the Student Achievement Gap (SAG) payment in the ensuing year. School district business managers/clerks should verify that the Students Imported from AIM into the SAG Report located in the MAEFAIRS application accurately reports the number of American Indian students enrolled in the district. Pursuant to ARM 10.21.205, changes to this designation will not be accepted after December 31.

## **Changes to Trustees Financial Summary**

If you find a material coding error on your FY 19 Trustees Financial Summary (TFS), please submit a revision to Keri Ludwig in the School Finance Division. As provided in ARM 10.10.504(6), changes to the TFS are limited to:

- Coding revisions between revenue and expenditure line items, provided no change occurs in the fund balance of the budgeted funds; or
- Revisions in the balance sheet accounts, provided no change occurs in the fund balance of the budgeted funds.

The Office of Public Instruction cannot process TFS changes that affect the fund balance in budgeted funds because fund balance is carried forward to the following FY budget, and a change in fund balance may impact the number of mills already levied in the fund. Revisions should be submitted as follows:

- Photocopy the original page of the TFS, with amounts to be revised crossed out and the correct amount written in.
- When sending balance sheet revisions, please send any expenditure and revenue line item changes that correlate with the revisions. The fund balance on the balance sheet should equal the ending fund balance shown on the Statement of Changes in the District Fund Balance report after the revisions are made.
- Change any sub-totals and totals that will be affected.
- Sign and date any sheets that contain a revision.
- Scan and email revisions to <a href="mailto:Keri.Ludwig@mt.gov">Keri.Ludwig@mt.gov</a>, or mail revisions to School Finance at PO Box 202501, Helena, MT, 59620-2501.

The deadline for submitting revisions is December 10. Non-material line item coding changes that affect fund balance in the budgeted funds for FY 19 must be reported as prior period adjustments on the TFS for FY 20. The district may need to adopt a budget amendment for the current year to record a prior period expenditure adjustment in a budgeted fund.

### **Compensation Expenditure Report**

MAEFAIRS is currently available for compensation expenditure reporting. The Compensation Expenditure Report requires that all employees who received a paycheck during 2018-19 fiscal year be entered into the district's 2018-2019 TOE data. For many districts, the TOE records did not include employees hired after the TEAMS application was closed. The missing employees can be entered into the compensation expenditure TOE screen in TEAMS. The Compensation Expenditure Report is due December 10th.

# **Operations**

### Quality Educator Loan Assistance Program

The 2019 Legislature passed HB 211 which revamps and funds the Quality Educator Loan Assistance Program. HB 211 changed the administration of the program from OCHE to OPI, reestablished funding for the program with a \$500,000 per year appropriation, and substantially revised the eligibility requirements. As before, the program has the broad intent of providing aid to rural schools to recruit and retain educators. The most important things to know about the new program are:

- Eligible educators can receive loan assistance in this school year.
- Schools must provide information in the current and future TEAMS data collections for identifying educator shortages, a step necessary to provide the funding to educators at a particular school.
- There is a provision for declaring an immediate educator shortage which can allow a school to confidently use the program as a recruiting tool this year.
- The OPI has published information on its <u>website</u> to explain the program and answer questions for educators and administrators.
